Thank you for your request of 2nd September. You requested the following information:

*'Do you have any fibre optic cables which belong to a third party which run along the troughing of the Railway lines from Sheringham to Norwich and Gt Yarmouth to Norwich?*

*If so where does this ultimately run from/to and who are the owners /Operators'*

I have processed your request under the terms of the Freedom of Information Act 2000 (FOIA).

I can confirm that we hold the information you requested. I can advise that there are no 3<sup>rd</sup> party cables on those branch lines. The only 3<sup>rd</sup> party cable around Norwich is between Lower Clarence Road building and Mercury Cables TAN (Telecom Access Node) located approximately 100M away near the road bridge. This cable is not trackside but is in the (ERL) Engineers Line Reference London Liverpool Street to Norwich (LTN) cable route.
