- 4) What information is asked for on the bt wifi registration form? BT WiFi hotspot before (eg Starbucks / McDonalds etc) you will be prompted to complete the registration form (below) Unreadable text totally blurred.
- 5) What links and sites are on the Main Menu and what external websites do IADs link to?
- 6) That IAD Disclaimer, I need the plain text so I can read

DWP Reply

- 1) What browser (firefox, google chrome etc.) do IADs use? IADs use Firefox browser.
- 2) I need plain text of Terms and Conditions page as they are impossible to read from your WAD Guide.
 - We do not have a plain text version of the T&Cs however I have attached screenshots to the email with this letter that clearly show the text on the 2 pages.
- 3) What date was Attachment WAD Guide Fol 2853 claimant guidance.pdf created?
 - This was published by the Digital Jobcentres and last modified on 12 November 2014.
- 4) What information is asked for on the bt wifi registration form? The form asks for an email address, a mobile phone number, your title, your first name, your surname and your postcode.

- 5) What links and sites are on the Main Menu and what external websites do IADs link to?
 - There are no links and sites on the main menu of an IAD the pictures shown in the guidance were from an old version of the WAD build. There is a shortcut to the Firefox browser and the Word Processor. Users can attempt to access any website but there are restrictions imposed through a third-party Web Protection. This product provides real-time protection against web-borne threats and inappropriate content at the network perimeter before they can enter the internal network, checking for known worms and viruses.
- 6) That IAD Disclaimer, I need the plain text so I can read. The Disclaimer link simply takes you to the Terms and Conditions which are attached to the email with this letter.
