Please provide details, including outcomes, of all fire safety compliance inspections conducted on high-rise residential buildings since 14 June 2017

Our response:

Since 14th June 2017 North Yorkshire Fire and Rescue Service have conducted 13 Fire Safety Inspections on High-Rise Buildings. The outcomes of which have been extracted from our internal database 'inspection outcomes' field, and detailed below:
