Freedom of Information Act 2000: Fines imposed by the Solicitors Disciplinary Tribunal (SDT)

Thank you for your Freedom of Information enquiry of 12 April 2017.

You asked for the following information on matters concerning the amount of fines imposed by Solicitors Disciplinary Tribunal (SDT):

- 1. The total amount of fines ordered by the SDT against solicitors in each of the last five years
- 2. The total amount of fines ordered by the SDT which were collected in each of the last five years
- 3. As of 31 March 2017, the outstanding amount owed in unpaid fines ordered by the SDT

I can confirm that HM Treasury holds some of the information within the scope of your request. The responsibility for collecting and enforcing payment of fines imposed by the SDT rests with HM Treasury. Where a Tribunal decision is the subject of an appeal, collection and enforcement of the fine imposed is suspended, pending the outcome of the appeal.

1. The total amount of fines ordered by the SDT against solicitors in each of the last five years

The information covering the entire period requested is not held on a calendar or financial year basis. However, I can advise that over the last five financial years (01 April 2012 to 31 March 2017) fines amounting to £1,918,600 have been imposed.

2. The total amount of fines ordered by the SDT which were collected in each of the last five years

The following amounts were collected in each of the last five financial years:

- 01 April 2012 to 31 March 2013 £252,289.92
- 01 April 2013 to 31 March 2014 £270,486.54
- 01 April 2014 to 31 March 2015 £194,178.19
- 01 April 2015 to 31 March 2016 £181,552.99
- 01 April 2016 to 31 March 2017 £522,874.10

Total £1,421,381.74

You should note that the amounts collected in a particular year may include fines imposed in that year, as well as fines imposed in earlier periods.

3. As of 31 March 2017, the outstanding amount owed in unpaid fines ordered by the SDT

As at 31 March 2017, the amount outstanding was £2,627,913.34.
