Re: Request for information (our ref: FR71-75)

I am writing in response to your request for information under the Freedom of Information Act 2000, received 17 August 2018. Our response is provided below:

Q1 The Local Authority is requested to provide a list of motor vehicles owned or leased to the council; currently licensed with the Driver and Vehicle Licensing Authority (DVLA) where the Registered Keeper of the vehicle is that of the Local Authority in the following format:

- 1. Registration Mark of each motor vehicle*
- 2. Fleet number allocated (if any)*
- 3. Chassis make and model*
- 4. Type of body fitted*
- 5. Date new or date of acquisition*

The Northamptonshire Fire and Rescue Service (NFRS) fleet list is currently being updated and therefore we are exempting this under section 22 of the Act: Information intended for future publication. The information requested will be published within one month and we will notify you once the updated information is available. Our fleet list is publicly available on our website: www.northantsfire.gov.uk under the Publication Scheme and sub-section 'Our Fleet'. Please note that NFRS does not publish or release vehicle registration marks as releasing this information could create a major vulnerability in our aim to protect our valuable assets and maintain the effective operation of our local and national emergency provision.

A separate response will be sent directly from Northamptonshire County Council (NCC) for NCC fleet.

Q2 Details of vehicles sold after use by the council since 1.1.2010 (if this information is still available)

NFRS does not hold this information.
