FREEDOM OF INFORMATION ACT 2000: MINISTRY OF DEFENCE POLICE: MDP FLEET

We refer to your email dated 23 May 2017 which was acknowledged on the same day.

We are treating your email as a request for information in accordance with the Freedom of Information Act 2000 (FOIA 2000).

In your email you requested the following information:

“Please supply me with a current vehicle Fleet list with the following information for *Marked* and *Unmarked* vehicles.

For marked vehicles please supply the following;

- Vehicle Registration**
- Vehicle Make and Model**
- Role of Vehicle**
- Where the vehicle is stationed**

For Unmarked vehicles please supply the following;

- Vehicle make and Model**
- Role of Vehicle.”**

A search has been carried out by the Ministry of Defence Police and some information in scope of your request is held.

“Please supply me with a current vehicle Fleet list with the following information for *Marked* and *Unmarked* vehicles.

For marked vehicles please supply the following;

- Vehicle Registration**
- Vehicle Make and Model**
- Role of Vehicle**
- Where the vehicle is stationed”**

“For Unmarked vehicles please supply the following;

- Vehicle make and Model**
- Role of Vehicle.”**

I have completed a public interest test and concluded that the public interest favours not releasing some of the information in Annex B. I am therefore withholding some of the information in accordance with FOI exemption Section 31 Law enforcement and Section 38 (Health and Safety)

- Section 31(1) Law enforcement applies because providing details of covert vehicles would reveal some information that would undermine law enforcement.
- Section 38 (1)(b) Health and Safety applies because providing details of specialist and covert vehicles could endanger the safety of Officers

If you are not satisfied with this response or wish to complain about any aspect of the handling of your request, then you should contact me in the first instance. If informal resolution is not possible and you are still dissatisfied then you may apply for an independent internal review by contacting the Information Rights Compliance team, Ground Floor Zone D, MOD Main Building, Whitehall, London SW1A 2HB (email CIO-FOI-IR@mod.uk). Please note that any request for an internal review must be made within 40 working days of the date on which the attempt to reach informal resolution has come to an end.

If you remain dissatisfied following an internal review, you may take your complaint to the Information Commissioner under the provisions of Section 50 of the Freedom of Information Act. Please note that the Information Commissioner will not investigate the case until the MOD internal review process has been completed.
