Thank you for your Freedom of Information (FoI) request received on 18 May. You wrote:

"Thank you for your reply to my request request-751671-6a59c613@whatdotheyknow.com

In your reply, you stated that The Flexible Support Fund budget is not allocated to individual offices and is managed at an Area level. In light of this information please provide information on The Flexible Support Fund budget vs expenditure that covers Westminster Area for 2018-2019; 2019-2020; 2020-2021.

Please advise the amounts budgeted for each year and what was actually spend. How much was left unused? Please provide the breakdown of what was it spend on if available."

DWP Response

The Flexible Support Fund budget is allocated and managed at DWP Area level. The Westminster Area falls within the DWP South Area, which covers approximately 250 Jobcentres. The requested budget and expenditure figures for the Financial years 2018-19 and 2019-20 are provided in the table below for South Area:

We can confirm that the Department holds the information you are seeking. However, Section 22 of the Freedom of Information Act exempts this information from disclosure. This is because the information is intended for publication at a future date.

This exemption requires the Department to weigh up the public interest for and against disclosure. There is a public interest in information being released as soon as possible. However, there is a strong public interest in permitting public authorities, such as DWP, to publish information in a manner and form and at a time of their own choosing. It is a part of the effective conduct of public affairs that the general publication of information is a conveniently planned and managed activity within the reasonable control of public authorities. Therefore, in this instance the Department has a reasonable entitlement to make its own arrangements to publish information.
