Thanks for forwarding the email from Lidl. We do want to work efficiently and effectively to help resolve the issue at hand, however, we don't consider a meeting at the time suggested, to be efficient use of time for all involved.

The proposed meeting is 10 working days from now. Even if we received the model today, 10 days would not be long enough for our model reviewers to complete a review and provide feedback to [REDACTED] and I. It may even be possible to involve one of our data/modelling team in a meeting. This may actually be beneficial, but, knowing how these model reviews work, I am confident that there just won't be anything of value to discuss with the relevant people on the 23<sup>rd</sup>.

I would like to suggest waiting until we receive the model work from Lidl. We will then be able to liaise with our data and evidence team about likely review timescales. This will allow us to give you and Lidl an idea of when we are likely to be able hold meaningful (read useful to all parties) discussions about the information that we have reviewed.

As such, we're still reluctant to agree to meet on the 23<sup>rd</sup>.

Again, I'm happy to provide you with progress updates and any views that we do have as and when you would like them, leading up to the point where we have completed our model review.
