Request under the Freedom of Information Act 2000

I write further to your request for information which was received on 14 February 2020, to confirm, in accordance with S.1(1)(a) of the Freedom of Information Act 2000, that Powys Teaching Health Board (PTHB) does hold the information that you require.

For ease of reference your request is set out below and our response follows:

Your Freedom of Information (FOI) Request:

1. In the last twelve months how many patients have been treated for Ulcerative colitis?
 - a. Of these patients how many were treated with Entyvio (vedolizumab)?
2. In the last twelve months how many patients have been treated for Crohn's disease?
 - a. Of the patients how many were treated with Entyvio (vedolizumab)?

Powys Response

Question 1: During the last 12 months I can confirm 9 attendances where the primary diagnosis was coded as Ulcerative colitis.

Question 1a: I can confirm none of the patients were treated with Entyvio (vedolizumab).

Question 2: I can confirm that PTHB is not able to provide all the detail requested as the numbers are so small. To provide such detailed information would render the individual identifiable and as such we have applied exemption Section 40(2) relating to Personal Information of the Freedom of Information Act 2000. This information is protected by the Data Protection Act


