Dear Mr Fryer

Thank you for your request for information under the Freedom of Information Act, received on 13 February 2020, reference number **FOI 20-070**. I can confirm that the Aneurin Bevan University Health Board has completed a search of its records and has established that it does hold information falling within the confines of your request. Please find below the response to your request.

In the last twelve months how many patients have been treated for Ulcerative colitis? Of these patients how many were treated with Entyvio (vedolizumab)?

In the last twelve months how many patients have been treated for Crohn's disease? Of the patients how many were treated with Entyvio (vedolizumab)?

The Health Board does hold information falling within the confines of your request; however, we are withholding this information and are using a Section 12 exemption of the Freedom of Information Act 2000. The information you seek is not centrally recorded and would require a manual trawl of individual patient records and it has been estimated that to provide the level of information being sought would exceed the cost of compliance.

Section 12 provides an exemption from a public authority's obligation to comply with a request for information where the cost of compliance is estimated to exceed the appropriate limit. The appropriate limit as stated in the Freedom of Information (Fees and Appropriate Limit) Regulations 2004 represents the estimated costs of one person spending 18 hours (or 2½ working days) in determining whether the Health Board holds the information, and locating, retrieving and extracting the information. If any part of the request exceeds the fees limit then Section 12 applies to the whole request.

Between 1 February 2019 and 31 January 2020, 993 Vedolizumab Injections 300mg 1 vial were dispensed.

I hope that you find this information useful. If you are not satisfied that all of the information you have requested has been provided, or because of the way your request has been handled, you have the right to request a review. This would be looked into in accordance with the Information Commissioner's Office (ICO) guidelines, which state that a request for review should be received within two months of you receiving the Health Board's response to your request for information. The ICO also recommends that public authorities carry out internal reviews within 20 working days.
