ENVIRONMENTAL INFORMATION REGULATIONS 2004 – INFORMATION REQUEST

Thank you for your request for information received by the Council on 3rd August 2018. We are considering it under the Environmental Information Regulations Act 2004. It has been assessed and the following information is provided in response:

Following the letter sent by the Department for Communities and Local Government regarding the safety of Large Panel System (LPS) buildings, can you provide details of the last time you carried out a structural survey of LPS blocks, what the survey found, and whether any action was taken as a result.

Large Panel System (LPS) buildings were surveyed, tested and remedial works undertaken where required in the late 1990s and early 2000s. Re-inspections were undertaken in 2008 and 2018 as required.
