- The location i.e. street or car park where Parking Charge Notices have been issued the most by the Council over the last 3 months (July 2017 -September 2017)











## RESPONSE

NOTE – I have assumed that you require data for Penalty Charge Notices rather than Parking Charge Notices as the council does not issue Parking Charge Notices which are issued by private parking enforcement companies. If your enquiry does actually concern Parking Charge Notices, none were issued April to September 2017.

- The number of Penalty Charge Notices the Council has issued for parking contraventions between July and September 2017 is: 2,800
- The revenue from the Penalty Charge Notices the Council has issued for parking contraventions between July and September 2017 is: £90,459
- The location where the most Penalty Charge Notices for parking contraventions have been issued the most by the Council between July and September 2017 is: Waterhouse Street
