	7(a)2	JR high-lighted the problem with taking more than 5 days to remove the fridge from Willesden Lane (Brent Zone 1). This is a serious problem because the time scale for removal should be 1 hour. With the current procedures within Veolia the earliest that any fly tipped fridge or freezer can be picked up is the next day. Procedures need to be put into place to collect fly tipped fridges and freezers immediately. It is not acceptable for the Veolia administration team to put the report onto a list for the fridge crew (collecting bulky waste fridges) to collect when next in the specific area. The fridge or freezer should be removed within the cleansing timescale for the appropriate Zone where dumped. JR and MOB asked for an urgent review and a corrective action plan to be produced explaining Veolia operational procedures to enable the removal of fly tips within the appropriate time scales.
