*Page 4 - "Information held by a public authority that is not published under this scheme can be requested in writing, when its provision will be considered in accordance with the provisions of the Freedom of Information Act.*

The information is presented as it is held within the spreadsheet used to manage these requests; this has been subject to alterations in design over the years and accordingly the information is not presented identically in each year and on occasions there are gaps. Minor redactions have been made to the 'subject' column of a small number of requests where that information is exempt under section 40(3)(a)(i) of the Act because it would identify individual requesters and its release would breach the first data protection principle (the fair and lawful processing of personal data) as set out in Schedule 1 of the Data Protection Act 1998.

The University does not consider your request to be a request for a dataset within the definition at section 11(5) of the Act, though we have supplied the information both as a pdf and as an Excel spreadsheet.
