Thank you for your request dated 4 February 2021 under the Freedom of Information (Scotland) Act 2002 (FOISA).

Response

The First Minister announced on 4 January 2021 a legal requirement to stay at home except for essential purposes. Schools and ELC settings would remain closed for the majority of pupils, except vulnerable children and children of key workers. This was a precautionary measure, based on the increased number of COVID-19 cases in Scotland, the growing proportion of these being of the new variant of COVID-19, and the high level of community transmission taking place. At the time, the First Minister made it clear that the priority was to reopen school buildings again for all children and young people, as quickly as possible, and to keep them open.




