Environmental Information Regulations 2004

Thank you for your recent request for the following information:

Please provide me with full food hygiene inspection details, including all reports on file and all evidence to include photographs etc, for Zorbas Greek Taverna.

Clarification as set out below:

- The time period applies to ALL reports that are on file from ANY time period, there is no time period as such but ALL reports.*
- The evidence relates to ALL of the above REPORTS; this includes photographs, videos, inspection forms, evidence of revisits/recorded forms, outcomes of enforcement action etc. as applicable on file.*

Response

Please be advised that the council does not hold videos as requested above.

Please find attached to this, and to subsequent emails (sent separately due to attachment size) the requested forms, evidence of visits and outcomes of enforcement action.

However please be advised that personal information has been redacted as it is exempt from disclosure under the exception in Regulation 12(3) of the Environmental Information Regulations (EIRs). Regulation 12(3) prevents us disclosing personal data about individuals, unless it is disclosed in accordance with both regulation 13 and the Data Protection Act.

The information is personal data as defined by the Data Protection Act 1998 (DPA). As it is information about someone else the release of this information would constitute a breach of Principle 1 of the DPA. This is because disclosure would be unfair to those people who could be identified from the information who have no expectation that their personal data would be made public.

This response therefore acts as a refusal notice under Regulation 14 of the Environmental Information Regulations.
