# HIGHWAYS ACT 1980 SECTION 119 THE PEAK DISTRICT NATIONAL PARK AUTHORITY PUBLIC FOOTPATH NO. 16 (Part) - PARISH OF FOOLOW PUBLIC PATH DIVERSION ORDER 2019

This Order is made by the Peak District National Park Authority ("the Authority") under section 119 of the Highways Act 1980 ("the 1980 Act") because it appears to the authority that in the interests of the owner of the land crossed by the footpath described in paragraph 1 of this order it is expedient that the line of the path should be diverted.

Mr. R Court of The Barn, Foolow Eyam Hope Valley S32 5QA has agreed to defray any compensation which becomes payable in consequence of the coming into force of this order and any expenses which are incurred in bringing the new site of the path into a fit condition for use by the public.

Derbyshire Dales District Council and Derbyshire County Council have been consulted as required by section 120 (2) of the 1980 Act.

#### BY THIS ORDER:

- 1 The public right of way over the land situate at Foolow and shown by a bold continuous line on the map contained in this order and described in Part 1 of the Schedule to this order shall be stopped up after 28 days from the date of the confirmation of this order or on such date as the Authority certifies that the work required to be done to bring the new site of the path into a fit condition for use by the public has been carried out (whichever is the later).
- 2 There shall be at the end of 28 days from the date of the confirmation of this order a public footpath over the land situate at Foolow described in Part 2 of the Schedule and shown by a bold broken line on the map contained in this order.
- 3 The rights conferred on the public under this order shall be subject to the limitations and conditions set out in Part 3 of the Schedule.

### PART 1

## DESCRIPTION OF SITE OF EXISTING PATH OR WAY

The whole width of that part of Public Footpath No. 16 Parish of Foolow shown by a bold continuous line on the Order Map commencing at Point A at grid

reference SK 1941 7676 running in a west south west direction to Point B at grid reference) 1921 7667 a length of approximately 230 metres or thereabouts.

#### PART 2

# DESCRIPTION OF SITE OF NEW PATH OR WAY

A 2 metre wide natural surfaced footpath in the parish of Foolow, shown by a bold broken line on the Order Map commencing at Point A at grid reference SK 1941 7676, running in a west south west direction to Point C at grid reference SK 1933 7672, then south west to Point D at grid reference SK 1929 7669, then west south west to Point E at grid reference SK 1926 7667, continuing west south west to Point F at grid reference SK 1922 7667, a length of approximately 215 metres or thereabouts.

A 2 metre wide stone surfaced footpath in the parish of Foolow, shown by a bold broken line on the Order Map commencing at Point F at grid reference SK 1922 7667, proceeding in a southerly direction to Point G at grid reference SK 1922 7666 and then west to Point H at grid reference SK 1921 7666 a length of approximately 20 metres or thereabouts.

#### PART 3

#### LIMITATIONS OR CONDITIONS

Pedestrian gates compliant with the current British Standard 5709:2018 located at Point C (GR SK 1933 7672), Point D (GR SK 1929 7669), Point E (GR SK 1926 7667), Point G (GR SK 1922 7666) and Point H (GR SK 1921 7666), as shown on the order map.

A 20cm high stone step 1m in width at Point H (GR SK 1921 7666), as shown on the order map.


