FREEDOM OF INFORMATION (SCOTLAND) ACT 2002

I refer to your recent request for information which has been handled in accordance with the Freedom of Information (Scotland) Act 2002.

For ease of reference, your request is replicated below together with the response.

Following written communication with you, you have requested an updated version of the request noted below with updated and active links.

I would like to request that any policy or procedure which outline, in any way, the duties, responsibilities and role of Patrol Supervisors, Force Incident Managers and Force Incident Commanders be disclosed to me.

Clarification was sought

I am interested in the role that the Force Incident Commander/Manager plays in regards to Roads, Armed and Local Policing.

Please be advised that information regarding incident Commander/Managers roles in relation to Roads Policing, Armed Policing and Local Policing is publicly available.

As such, in terms of Section 16 of the Freedom of Information (Scotland) Act 2002, I am refusing to provide you with the information sought. Section 16 requires Police Scotland when refusing to provide such information because it is exempt, to provide you with a notice which:

- (a) states that it holds the information,
- (b) states that it is claiming an exemption,
- (c) specifies the exemption in question and
- (d) states, if that would not be otherwise apparent, why the exemption applies.

I can confirm that Police Scotland holds the information that you have requested and the exemption that I consider to be applicable is set out at Section 25(1) of the Act - information otherwise accessible:

"Information which the applicant can reasonably obtain other than by requesting it under Section 1(1) is exempt information"
