Thank you for your email of which I can confirm is considered to be a request for information under the Freedom of Information Act (FOIA) 2000. You requested information on the following vehicle:

"ex mod land rover defender 90; military registration number 60KJ00 and chassis number SALLDVAC7HA700906"

I can confirm that the Ministry of Defence holds information relevant to your request. Unfortunately, following the closure of MERLIN it is only possible to retrieve information held on the archived version of the database, which is attached. Also enclosed are the vehicles maintenance and repair records from JAMES.
