- 5) Specifically please confirm whether this is as a result of HTE Frameworks: 'TWS Lot 5 Specification' Section 5 clauses 5.1 and 5.2 (see pg 21), in which case the advice is patently NOT external legal advice as it has come form the provider of the scheme who has an obvious potential conflict of interests by having a financial interest in the trust adopting the scheme.
