**There is currently one CT scanner within the trust. This is located in Southwood Building, level 1, and is a Siemens SOMATOM Force scanner. This was commissioned on 11/12/2014**

Amount of Injector pumps currently within CT, please could you include make, model and age?

**There is currently one injector pump currently within CT. This is a MEDRAD Stellant CT injection system by Bayer, and was commissioned on 01/01/2008.**
