Dear Kirsten

Apologies if there has been any confusion. We were contacted by Simon from Canterbury City Council asking us to help as he had been approached by parties acting on behalf of both schools regarding sites etc and he wanted (1) for me to be involved and (2) to meet both parties together. Lorraine rang him for me (I have been in back to back meetings for the last few days) to say that I would be happy to join any meeting but to explain that although we would ask the schools if they

would be happy to attend the same meeting, given both parties are in “competition” and may be talking about the same or perhaps different sites....it would be more sensible to meet separately.

The meeting is therefore more about sites and potential planning issues than education and I think it would need to either be for or include your architect team Kirsten. Simon has accepted that the meetings would be best separate and has suggested morning of the 11th April for Barton Court (Brook House) as QE has already accepted the 15th (I can also attend at this date and time).

I have received the email below from my PA but I am slightly confused. I thought this meeting was about education rather than site or planning? I was told it was a meeting with Marisa and Swale not with Simon Thomas?

BCAT architects, XXX, have been trying to arrange a meeting with Simon on their own without QE to discuss planning and site options, but we wanted this meeting separate to QE.
