I realise some of you who haven't followed the history of this scheme may wonder why there are often two sets of documents for each aspect of the assessment. The scheme on which DfT Ministers gave initial approval is that from the Postwick junction (A47) to the A140. That is what we now need to assess. Norfolk are paying to extend the scheme to the A1067. They have provided some equivalent information for the full A47-A1067 as well as that we wanted on just the A47-A140 in case we need to compare and provide any information to Ministers. Hopefully this is clear but happy to clarify further.

If that is a problem I would like to be able to provide the Committee with the template by the time the meeting takes place.
