Sorry for the delay in response. I am currently on leave (Tuesday only)

I have uploaded the separate annexes A-G to the file share site (the cd's sent will have these as one file)

I have also uploaded two separate plans as requested to the file share site

I have attached the updated public accounts tables to this email

The Local Authority contribution for the Postwick to A1067 scheme is broken down as follows:

NCC contribution £28.657m
CIL contribution (underwritten by NCC) £40.000m
Total LA contribution £68.657m

The £40m CIL contribution is towards the Postwick to A1067 scheme. This contribution has never been split between the A140 and the A1067 schemes and has only be considered as a contribution towards the Postwick to A1067 scheme as a whole.

I will check the funding bid documents sent tomorrow, all documents currently are draft and therefore should be treated as such. I will confirm tomorrow.

I will also respond to your most recent email with the question below tomorrow (Wednesday)

There are lots of numbers of houses and jobs in the various documents. Many cover the whole New Anglia area whilst others relate only to Norwich. Can you let me have the correct numbers for the Norwich area and if possible there exact numbers of houses / jobs that are directly linked to NNDR.

Thanks. I have been able to file the various documents but please could you break up the additional annexes A to G pdf as we may need to send various bits of that to different people, unless you have already done this in the CD's you have sent which I haven't yet received. I note also that the version of the FA bid documents in that overall pdf is slightly different and also is signed.

In addition could be have an updated map please. You previously supplied the attached version. That would seem to be right except it would be good to show separately Postwick and also the A140 to A1067 sections given we will be discussing the different elements in the internal templates and submission to Ministers.

In addition I note that the FA bid says the following:

The Public Accounts Tables are presented on the basis of a DfT contribution of £67.49m. NCC has made a request for additional funding in 3.4 below and should this be granted the Public Accounts Tables will be updated and resubmitted.

We will need any up dated tables asap to keep up the moment of our assessment.

I would also like confirmation on the amount of funding NCC are putting into this scheme. From the FA bid document it looks as though you are putting in £23.40m. I assume that the remainder of the £40m CIL is being used for the A140-A1067 section? Is that correct? What funding is NCC itself providing to the A47-A140 section?
