Your request for information reads:

"I would like to request further disclosure of the full costs associated with the University of Birmingham Executive Board (UEB) with some additional detail.

I would like to request summary information covering the full costs of associated with the UEB over the past 5 years (financial year ends 2014 through to 2018). This should include the remuneration (as disclosed in note 7. of the University's annual accounts) but in addition should include any other costs such as employer's pensions contributions, expense claims, and the value of any other benefits such as rent free accommodation.

In addition to the summary information above, I would also like to request a detailed itemised list of all expenses claimed for the financial year ending July 2018 covering members of the UEB for that year. Again, this should also include disclosure of any other benefits such as rent free accommodation, private transport, food, and any other benefits provided at the University's expense.

This information should be available from the University's finance department."

The University of Birmingham responds:

The University of Birmingham is required to respond to a request made under the Freedom of Information Act 2000 ("the Act") if it holds the information being requested, unless it is appropriate to apply one of the limited exemptions set out in the Act.

I would like to request summary information covering the full costs of associated with the UEB over the past 5 years (financial year ends 2014 through to 2018). This should include the remuneration (as disclosed in note 7. of the University's annual accounts) but in addition should include any other costs such as employer's pensions contributions, expense claims, and the value of any other benefits such as rent free accommodation.

The University publishes in its Annual Accounts details of remuneration paid to the Vice-Chancellor; to key management personnel (ie UEB) and staff paid more than £100,000 in accordance with HEFCE (Higher Education Funding Council for England) and OfS (Office for Students) guidance. https://www.birmingham.ac.uk/university/governance/Council/accounts.aspx

As a requirement of the performance of his office, the Vice-Chancellor occupies University-owned premises at the University of Birmingham. The property is used intensively for corporate meetings and events. This is detailed in the Annual Accounts.

Remuneration data for 2017/18 will be published in this year's Annual Accounts after approval by Council.

The Refusal Notices below explain why the University is referring you to the Annual Accounts.

The table below details total expenses claimed by members of UEB in each of the University Financial Years 2013/14 - 2016/17.

The University holds the remuneration information requested for 2017/18 and, following consideration and approval by the University's Council, it will be published in the 2017/18 Annual Accounts towards the end of 2018 or beginning of 2019. The University has considered whether to provide you with this information ahead of that publication date, but has decided that it would not be appropriate to do so before the information and other contextual data has been through the proper processes of approval, with review and approval by External Auditors, Audit Committee, SPRC (Strategy, Planning and Resources Committee) and the University's Council, and because the University has a well-established practice of publishing this information annually in its Annual Accounts. Taking these factors into account, the University does not consider it to be in the public interest to disclose this information.

Therefore, under Section 22 of the Act, the University has not provided you with the information you have requested.
