Thank you for your request for information:

Please find the Trust's response below

I am undertaking a study on the numbers of Public Health/Welfare Funerals undertaken by NHS Trusts. I would appreciate it if you would provide answers to the following FOI request.

1. The total number of public health funerals (where the deceased has no relatives or there is no one else willing to pay) that your Trust has undertaken for the financial years 2010/11, 2011/12, 2012/13?

RESPONSE: 2010/11 = 8, 2011/12 = 6, 2012/13 = 5

2. The number of public health funerals that your Trust has undertaken by gender for the past 3 financial years?

RESPONSE: The number of female funerals that have taken place is very low, and the individuals may be identifiable. Therefore we are unable to provide the figures for this question.

3. The number of public health funerals that your Trust has undertaken by age for the past 3 financial years? Since April 2010, how many cases have there been where family and friends refuse to finance or make arrangements for their relatives funeral?

RESPONSE:

31-40 = One

41-50 = Four

51-60 = Three

61-70 = Six

71-80 = One

81 + = Two

Unknown = Two

4. How much have the burials/cremations cost the Trust broken down by year for the last three financial years? This cost information does not need to include administrative or staff costs, and before any costs are claimed back by the local authority from the deceased's estate RESPONSE: 2010/11 = £10,200, 2011/12 = £5,200, 2012/13 = £11,500

NB: These figures are the total spend per annum as charged in the Trust's accounts, and are net of any monies received from bank accounts, insurance policies etc. It is quite feasible that some or all of the cost of a death in say 2011/12 will be reflected in the figures for 2012/13 (hence the large increase between the two years).

5. How much does your trust typically (average cost) pay for a Public Health Funeral? RESPONSE: £1,650

6. What does your Trust provide at a Public Health Funeral? RESPONSE: Basic cremation (coffin service).

- 7. What relationship do you have with your local council(s) regarding funerals of this nature? RESPONSE: The local council undertakes house clearances and sends the Trust any paperwork re bank accounts, Will or insurance policies, or valuables, ie. jewellery/money they find. The Trust then endeavours to establish if the deceased had any way of reimbursing us the funeral costs. The council also sends any monies received for the sale of white goods/furniture etc from the deceased's home.
- 8. Have you observed any of the following over the last three years?
- Higher numbers or people dying without any income or assets NO
- Higher numbers of people dying with family or friends unable to contribute to the costs of a funeral NO
- Higher numbers of people dying with family or friends unwilling to contribute to the costs of a funeral - NO
- Higher numbers of people dying with no friends or family NO
