#### Dear Mr Park

Thank you for your email of 6 April 2021 requesting information, as set out below, under the Freedom of Information Act 2000.

The questions as set out in your request for information were as follows:

- 1. The number of employees each month from February 2020 to March 2021 and their departments;
- 2. The total staff each month on "furlough" under the Coronavirus Job Retention Scheme placed on furlough;
- 3. The departments these employees were within;
- 4. The amount claimed and paid by the "furlough" scheme by HMRC;
- 5. The number of redundancy payments made from Feb 2020 to March 2021 and the total figure of payments; and
- 6. The organisation chart of staff.

Having considered your request under the Freedom of Information Act 2000, I can confirm that Belfast City Council holds the information you have requested and has decided that it can be disclosed into the public domain. Accordingly, the information which can be disclosed is provided below. Please note that if any of this information is to be published it should be attributed to being Belfast City Council's response to a FOI request.

- 4. The amount claimed and paid by the "furlough" scheme [Coronavirus Job Retention Scheme] by HMRC up to the end of March 2021 is £1,568,143.09.
- 5. There has been a total of 31 employees who have received redundancy payments from February 2020 to March 2021 as part of a voluntary redundancy exercise. The total figure of redundancy payments for this period was £1,133,138.40.
- 6. The functional diagram for Belfast City Council is enclosed in appendix two. This illustrates the functions within each department including headcount.


