4. **Start date & duration of framework**
5. **Is there an extension clause in the framework(s)/contract(s) and, if so, the duration of the extension?**
6. **Has a decision been made yet on whether the framework(s)/contract(s) are being either extended or renewed?**
7. **Who is the senior officer (outside of procurement) responsible for this contract?**

You have a right to have the existence of the information requested either confirmed or denied unless the Council claims an Absolute Exemption under Part II of the Act. Officers are currently establishing whether the information requested is held and I will write to you with the Council's response by 11 June 2021 which is 20 working days following receipt of your request.

Freedom of Information and the Coronavirus:

The Information Commissioner recognises the unprecedented challenges facing local authorities during the coronavirus (COVID-19) pandemic, in particular that resources, whether they are finances or people, may be diverted away from usual compliance or information rights work.
