Freedom of Information Act 2000 - Request for Information

Thank you for your email received 14 January 2020 requesting the following information:-

"Please can you provide me with the job description, job description questionnaire (job evaluation document) and salary of the role of Gardener within your organisation please."

Our obligation

The Council is treating your request as having been made under the Freedom of Information Act 2000 (the "Act").

When dealing with requests for information, the Council's obligations include:

- (1) confirming or denying whether it holds information of the description specified in the request; and
- (2) communicating the information requested to the applicant. You should note that this is effectively a decision that the information can be released into the public domain and not simply to the specific applicant.

Under the Act, the Council is required to release any information that it holds to you unless an exemption applies.

Response to your request

I confirm that the information you have requested is held and I can give you the following:-

Pleas see the attached documents. The salary grade for the Landscape Operative is Grade 2 - £17,711 - £18,426 per annum.

If you are dissatisfied with the handling of your request, you may ask the Council for an internal review of the decision within 20 working days. Someone other than the person who took the initial decision will conduct the internal review. Requests for an internal review
