CHAP. cxvi.

An Act for confirming a Scheme of the Charity Commissioners for the Jewish United Synagogues. [14th July 1870.]

1870.

WHEREAS the Charity Commissioners for England and Wales, in their report to Her Majesty of their proceedings during the year one thousand eight hundred and sixty-nine, have reported that they have provisionally approved and certified (among other schemes for the application and management of charities) a scheme for the Jewish United Synagogues, and such scheme is set out in the appendix to their said report:

17th Report, dated 26th February 1870.

And whereas it is expedient that the said scheme, as the same is set out in the schedule to this Act, should be confirmed:

Be it enacted by the Queen's most Excellent Majesty, by and with the advice and consent of the Lords Spiritual and Temporal, and Commons, in this present Parliament assembled, and by the authority of the same, as follows:

1. The said scheme shall be confirmed and take effect.

Scheme confirmed.

THE SCHEME contained in the Schedule to the Act 33 & 34 Vict. cap. 116 intituled "An Act for confirming a Scheme of the Charity Commissioners for the Jewish United Synagogues," WAS ALTERED AND MODIFIED, on 24th May, 1880, on 31st October, 1926, and on 28th February, 1954, in the manner provided for by Clause 67 thereof; and it was Resolved, That the said alterations and modifications of the Scheme shall be read and construed with and as part of the Scheme. And the provisions of the Scheme shall, unless and save so far as such application shall be repugnant, apply to the said alterations and modifications.

Alterations and modifications in Scheme.

SCHEDULE to the Act.

UNION OF THE SYNAGOGUES.

Scheme, as amended in the manner provided by Clause 67 thereof, on 24th May, 1880, 31st October, 1926, and 28th February, 1954.

Existing regulations annulled.

1. The laws and regulations at the time of the establishment of this Scheme or at any time previously thereto in force relating to the synagogues following, (that is to say), the Great Synagogue, St. James's Place, Aldgate, in the city of London; the Portland Street Branch Synagogue, Great Portland Street, in the county of Middlesex; the Hambro' Synagogue, Church Row, Fenchurch Street, in the city of London; the New Synagogue, Great St. Helen's, Bishopsgate, in the city of London; and the Bayswater Synagogue, Chichester Place, Harrow Road, in the county of Middlesex; and to the subsidiary charities of the said respective synagogues; and the constitutions of the said respective synagogues; and the treaty or treaties at the time of the establishment of this scheme, or at any time previously thereto, in force between the said respective synagogues or any of them, are hereby annulled.

Uniting of present constituent synagogues.

2. The synagogues hereinbefore named shall unite and form one institution, to be called "The United Synagogue", קיק כנסת ישראל and shall be the present constituent synagogues of the said institution, each of the said synagogues, whether the same has been independent, or a branch of any other or others of them, being one of such constituent synagogues; and the subsidiary charities of the synagogues hereinbefore named shall be subsidiary charities of the United Synagogue.

Clause of Scheme, 14 July, 1870.

Future constituent synagogues.

3. Upon the admission as a constituent of the United Synagogue as hereinafter mentioned of any synagogue other than the synagogues hereinbefore named, the same shall be a constituent synagogue of the United Synagogue, and the subsidiary charities thereof shall be subsidiary charities of the United Synagogue.

Meaning of words constituent synagogue, or constituent synagogues. 4. Whenever the words constituent synagogue or constituent synagogues are herein used, the same shall refer to the constituent synagogues for the time being of the United Synagogue, including as well the synagogues hereinbefore named as any other synagogue which shall have been admitted as a constituent synagogue as hereinafter mentioned.

Objects of the United Synagogue. 5. The objects of the institution to be called "The United Synagogue" shall be the maintaining, founding, erecting, and carrying on, in London and its neighbourhood, of places of worship for persons of the Jewish religion who conform to the Polish or German ritual, the giving of instruction in religious subjects to persons of the Jewish religion in conformity with the said ritual, the providing means of burial of persons of the Jewish religion, the relief of poor persons of the Jewish religion, the contributing with other Jewish bodies to the maintenance of a Chief Rabbi and of other ecclesiastical persons, and to other communal duties devolving on Metropolitan congregations, and other charitable purposes in connection with the Jewish religion.

5a. The United Synagogue shall have the power to found, erect, and promote the establishment of halls or institutes, or other places for religious and social purposes, such halls, institutes or other places to be managed by a <u>committee</u> of the Council of the United Synagogue or by such honorary officers and boards of management of constituent synagogues as the Council may decide.

Halls for religious and social purposes.

5b. The United Synagogue shall have the power:—

Nonconstituent synagogues and unions thereof.

- To promote or form or to assist in promoting or forming, in any district or districts in Great Britain, a union or unions of synagogues for persons of the Jewish religion who conform to the Polish or German ritual, such synagogues not being constituent synagogues of the United Synagogue, in such manner as shall be mutually agreed to by the Council of the United Synagogue and the governing bodies of such non-constituent synagogues. Each such union shall be governed by a Council which shall be formed in the like manner as and have the like powers and duties as are herein provided in respect of the Council of the United Synagogue, with such alterations and modifications as may be determined by the Council of the United Synagogue. Each such union of non-constituent synagogues situated in the Metropolitan area shall contribute to the maintenance of the Chief Rabbinate and the Beth Din, and to the general purposes of the United Synagogue, and to the other communal and charitable purposes undertaken by the United Synagogue; and each such union of non-constituent synagogues situated outside the Metropolitan area shall contribute to the maintenance of the Chief Rabbinate and to the general purposes of the United Synagogue, and to such of the other communal and charitable purposes undertaken by the United Synagogue as are not confined to the Metropolitan area.
- (ii) To found or to assist in founding, in any district or districts in Great Britain, places of worship for persons of the Jewish religion who conform to the Polish or German ritual, such places of worship not being or necessarily to be or become constituent synagogues of the United Synagogue, in such manner as shall be mutually agreed to by the Council of the United Synagogue and the other persons (if any) promoting the foundation of such non-constituent synagogues. Each such non-constituent synagogue shall contribute to the like purposes as hereinbefore provided in the case of a union of non-constituent synagogues.
- (iii) To grant to any non-constituent synagogue or union of non-constituent synagogues, that shall contribute as aforesaid, representation upon the Council of the United Synagogue for the purpose of achieving common religious and charitable objects; and if the Council of the United Synagogue shall resolve to grant such representation the number of representatives and the period for which they shall serve shall in each case be such as the Council of the United Synagogue shall determine. Provided that the

- representatives of each such synagogue or union shall be male persons of the age of 21 years and upwards, and that the time and manner of their election as representatives and their qualifications for such election shall be as the Council of the United Synagogue may from time to time approve.
- (iv) To give or lend to the Council of any such union of non-constituent synagogues or to the governing body of any non-constituent synagogue such sum or sums of money and upon such conditions as to security, payment of interest on, and repayment of principal of such loan or otherwise as the Council of the United Synagogue shall from time to time determine.

Religious observances.

6. The form of worship in each of the constituent synagogues shall be in accordance with the Polish or German ritual.

Definition of membership of United Synagogue. 6a. The Members of the United Synagogue shall consist of the following persons:—

(A.) Members of a constituent synagogue, that is to say:—

- (i) Male persons who shall have effected membership at any constituent synagogue in such manner as the Council may from time to time determine, and who shall pay not less than the appropriate schedule rate fixed in accordance with Clause 48 hereof, hereinafter called "schedule members".
- (ii) All other male persons who shall have effected membership at any constituent synagogue in such manner as the Council may from time to time determine and who shall have been permitted to pay less than the appropriate schedule rate fixed in accordance with Clause 48 hereof, to be known as "non-schedule members".
- (iii) Female persons who shall have effected membership at any constituent synagogue in such manner as the Council may from time to time determine, and who shall pay not less than the appropriate schedule rate fixed in accordance with Clause 48 hereof, hereinafter called "female members".
- (iv) Female persons who shall have effected membership at any constituent synagogue in such manner as the Council may from time to time determine, and who shall have been permitted to pay less than the appropriate schedule rate fixed in accordance with Clause 48 hereof, to be known as "non-schedule female members".
- (B.) Assessed members of the United Synagogue, that is to say:—
 All persons (whether male or female) not being members of a constituent synagogue who shall contribute to the United Synagogue such annual sum for the right of membership as the Executive Committee shall determine, and shall not be more than one year in arrear in payment thereof.

"Council" for "Vestry".

- 6b. The Vestry of the United Synagogue shall be called the Council of the United Synagogue, and the Scheme shall be read as if the word "Council" were substituted for the word "Vestry" wherever such word occurs.

- (D.) The two treasurers for the time being of the burial society of the United Synagogue.
- (E.) All persons who have served any of the offices following, that is to say:—
 president of the United Synagogue, vice-president of the United Synagogue,
 treasurer of the United Synagogue, treasurer of the bequests and trusts
 funds of the United Synagogue, and treasurer of the burial society of the
 United Synagogue.
- (F.) Representatives of the constituent synagogues, that is to say:—
 - (i) Those elected biennially.

Male persons, not being at the time of election members of any of the preceding classes, to be elected by the constituent synagogues in the manner hereinafter appearing, who shall at the duly prescribed date of nomination be schedule members of the electing synagogue, of the age of twenty-one years and upwards, and not more than a year in arrear in payment of their accounts to the United Synagogue, and who shall, during the whole of two consecutive years immediately preceding such date, have been schedule members of any of the constituent synagogues (that is to say, either during the whole of such period at one, or during part at one and the remainder at another or others of the constituent synagogues). There shall in the year 1955 and in every alternate year thereafter be held a meeting at each of the constituent synagogues, and at such meeting there shall be elected representatives of the synagogue on the Council on the basis of one such person for every whole number of one hundred members of the constituent synagogue duly returned to the Council as having been members of the constituent synagogue three months before the date of the summoning of the meeting, provided that the number of representatives so elected on the Council shall be not less than two in the case of any one constituent synagogue.

The persons entitled to vote at the meeting shall be all members of the constituent synagogue as defined in Clause 6a (A.) (i), (ii), and (iii), of the age of twenty-one years and upwards, who shall during the whole of the year immediately preceding the date thereof have been members of the same constituent synagogue, and shall not, at the date of the meeting, be more than a year in arrear in payment of their accounts to the United Synagogue. For the purposes of this section, mem-

bership, previously to admission, of a synagogue which shall be admitted as a constituent synagogue within the prescribed period of two years or one year (as the case may be) shall be equivalent to membership of the same synagogue as or in the character of a constituent synagogue; and accounts which at the date of the admission of a synagogue shall be due or accruing due to it from any person, shall, in determining whether or how long such person shall have been in arrear in payment of his or her accounts to the United Synagogue be considered as forming part of such last mentioned accounts. In the case of a synagogue admitted as a constituent synagogue within the two years immediately preceding the date of the meeting, the qualifications for election and voting respectively prescribed in the next following section (F.) (ii) shall apply in substitution for the respective qualifications prescribed in this section.

(ii) Those elected, forthwith after its admission, by a newly-admitted constituent synagogue.

Male persons, not being at the time of election members of any of the preceding classes, who shall, at the duly prescribed date of nomination be schedule members of such synagogue as a constituent synagogue, of the age of twenty-one years and upwards, and not in arrear in payment of their accounts to the United Synagogue, to be elected in the manner hereinafter appearing, forthwith after its admission, by a synagogue newly-admitted as a constituent synagogue. There shall be held a meeting at the said synagogue, on a date to be approved by the Council, and at such meeting there shall be elected one such person for every whole number of one hundred members of the same synagogue duly returned to the Council as being members of the synagogue as a constituent synagogue, provided that the number of representatives so elected on the Council shall be not less than two in the case of any one constituent synagogue.

The persons entitled to vote at the meeting shall be all members of the constituent synagogue as defined in Clause 6a (A.) (i), (ii) and (iii), of the age of twenty-one years and upwards, who at the date thereof are not in arrear in payment of their accounts to the United Synagogue. The persons so elected at an election held at a newly-elected constituent synagogue shall serve until the time at which the persons elected at the next following election held at the same constituent synagogue under Clause (F.) (i) shall commence to serve.

Proviso limiting size of Council, added 28 Feb., 1954.

Provided always that if at any time the total number of representatives who have been elected by all the constituent synagogues under Clauses (F.) (i) and (F.) (ii) shall exceed 225, the Council shall so amend the basis of representation as to provide that at the next following election the total number of representatives to be elected under Clause (F.) (i) shall not exceed 175, but not so as to reduce the number of persons to be elected under this proviso below two in the case of any one constituent synagogue.

(G.) Male persons (not being at the time of election members of any of the preceding classes) who shall have been elected to the Council as representatives of unions of non-constituent synagogues under the provisions of Clause 5b (iii) hereof.

Two treasurers of the United Synagogue, two treasurers of the bequests and trusts funds and two treasurers of the burial society shall be elected in the year 1955, and in every alternate year thereafter by the Council from among male persons of the age of twenty-one years and upwards, being at the time of election schedule members at a constituent synagogue, and who shall during the whole of two consecutive years immediately preceding the date of election have been such schedule members at any of the constituent synagogues (that is to say, either during the whole at one, or during part at one and the remainder at another or others of the constituent synagogues) and shall not at the date of election be more than a year in arrear in payment of their accounts to the United Synagogue. For the purposes of this clause, membership, previously to admission, of a synagogue which shall be admitted as a constituent synagogue within the prescribed period of two years, shall be equivalent to schedule membership of a constituent synagogue, and accounts which at the date of the admission of a synagogue shall be due or accruing due to it from any person, shall in determining whether or how long such person shall have been in arrear in his accounts to the United Synagogue, be considered as forming part of such last-mentioned accounts. The two treasurers, the two treasurers of the bequests and trusts funds and the two treasurers of the burial society so appointed shall be honorary officers of the United Synagogue. The present elders of the United Synagogue shall serve until the time in the year 1955 at which the seven elders to be elected under this clause shall commence to serve.

The Executive Committee of the United Synagogue.

11. The following shall constitute an executive committee of the Council for general purposes, and shall be called "The Executive Committee":—the honorary officers for the time being of the United Synagogue (that is to say, the president, the two vice-presidents, the two treasurers, the two treasurers of the bequests and trusts funds, and the two treasurers of the burial society), the seven elders for the time being, the two wardens and the financial representative for the time being of each of the constituent synagogues, the treasurers for the time being of the District Synagogues Council, and the respective chairmen for the time being of the Building Committee, the Visitation Committee, the Welfare Committee, the Board of Management of the Beth Hammidrash and Beth Din and the respective chairmen for the time being of such other committees of, or under the control of, the Council, as the Council may from time to time determine.

The present president and vice-presidents of the United Synagogue shall hold office until the time in the year 1955 at which the president and vice-presidents of the United Synagogue to be elected under this clause shall commence to hold office. All presidents and vice-presidents of the United Synagogue elected under this clause shall during their term of office be honorary officers of the United Synagogue. The president and vice-presidents shall be ex officio members of all committees of, or under the control of, the Council.

13. The president shall be chairman at all meetings of the Council and Executive Committee at which he shall be present; and one of the vice-presidents, or, if the vice-presidents shall also be absent, one of the treasurers of the United Synagogue, shall be chairman at any of such meetings, if and while the president shall be absent therefrom. If the president, vice-presidents, and treasurers of the United Synagogue shall all of them be absent from any such meeting, the members present shall elect one of their number to be chairman.

The said committee shall consist of the treasurers of the bequests and trusts funds for the time being (one of whom shall preside at its meetings), four persons who shall be elected in the year 1955 and in every alternate year thereafter by the Council from among the members thereof, one warden from each of the constituent synagogues to be appointed annually by the board of management and two representatives of the District Synagogues Council to be elected biennially by that body. The present overseers' committee and the present bequests and trusts committee shall serve until the time in the year 1955 at which the bequests and trusts committee to be elected under this clause shall commence to serve.

The funds specified in the fifth schedule (being funds belonging to or administered by the Great, Hambro', and New Synagogues respectively, which were heretofore applicable to special purposes, and forming subsidiary charities of the said synagogues), and the income thereof, shall be held by the respective trustee or trustees for the time being thereof upon, with, and subject to the same respective trusts, powers, and provisions as are now applicable to the same respectively, save and except, and it is hereby declared, that in any case in which a power or discretion is or has been reposed in any officer or officers, body or bodies of or connected with any of the present constituent synagogues, such power or discretion is hereby conferred upon and reposed in and shall be exerciseable by the Council, or any committee of the Council, or any officer or officers of the United Synagogue to whom the Council shall delegate the same; and save and except, and it is hereby declared, that in any case in which a person or persons, or a class or classes of persons, or an institution or institutions standing in any relation to any of the present constituent synagogues; shall be an object or objects of the charity constituted by any of the said funds, the object or objects of the charity representing the same shall be a person or persons, or a class or classes of persons, or an institution or institutions, standing in a similar relation to the United Synagogue generally; and save and except, and it is hereby declared, that the trusts, powers, and provisions now or heretofore applicable to the said respective funds may in other respects be from time to time varied and modified by the Council, so far as shall be deemed necessary for the due administration of the same in connexion with the United Synagogue.

Clause of Scheme, 14 July, 1870. 35. All property belonging to or held in trust for the present constituent synagogues, not specified in the schedules, shall belong to or be held in trust for the United Synagogue, and shall be dealt with and disposed of as the Council shall from time to time direct.

All property, real or personal, present or future, of the United Synagogue, or of a Synagogue admitted or that shall be admitted as a constituent synagogue, shall, if the said property be not otherwise provided for in this Scheme, belong to or be held in trust for the United Synagogue, and shall be dealt with and disposed of as the Council may from time to time direct, subject however as to the site and buildings of any such synagogue to Clause 28 and Clause 35b of this Scheme.

Provisions for continuing or discontinuing a synagogue.

So long as the annual income of a constituent synagogue shall amount to or exceed the annual sums which shall be expended for the maintenance and support of such synagogue, together with the sums which the same synagogue shall be liable to contribute to the general communal and charitable purposes of the United Synagogue in pursuance of the objects of this Scheme, the Council shall not discontinue the synagogue as a place of worship, or sell the site on which the synagogue is built, or the buildings thereon, or otherwise deal with the same, so that such site and buildings cannot be used as a synagogue or place of worship; provided, nevertheless, that if it shall, in the opinion of the Council; be desirable that any such synagogue shall be discontinued as a place of worship, although the said income shall amount to and exceed the annual sums hereinbefore mentioned, a meeting shall be held at which all members of the constituent synagogue as defined in Clause 6a (A.) (i), (ii) and (iii), who shall, during the year immediately preceding the date thereof, have been members of the same synagogue, and shall not at the date of such meeting be more than a year in arrear in payment of their accounts to the United Synagogue, shall be entitled to vote. And the question whether the said synagogue shall be discontinued as a place of worship shall be put to the meeting. And in the event of the majority of members present and entitled to vote at the meeting voting in favour of such discontinuance, and of at least one-half of the persons entitled to vote (as well those present at the meeting as those absent therefrom) confirming the said vote at the meeting, or within a stated time thereafter, by recording the same in such manner as the Council shall determine, the said constituent synagogue shall or may be discontinued as a place of worship, and the provision in this clause as to not discontinuing such a synagogue as a place of worship and disposing of the site thereof or the buildings thereon shall not apply; provided that no purchaser at a sale by a trustee or trustees, by the direction of the Council, shall be bound to see or inquire whether or not the same is in breach of the provisions of this clause, but such sale shall, so far as concerns the safety or protection of a purchaser thereat, be valid, whether or not the same is in breach of the provisions of this clause.

Debts and liabilities transferred.

36. All debts, obligations, and liabilities at the date of the establishment of this Scheme due or existing to or from the present constituent synagogues, or any of them, or any of their subsidiary charities, or to or from any officer or officers, body or bodies, trustee or trustees of or connected with the present constituent synagogues or any of them, in respect of the same constituent synagogues or any of them, or any of their subsidiary charities, shall be debts, liabilities, or obligations of the United Synagogue and its subsidiary charities respectively; and in any case in which any person or persons shall be entitled to or bound by the same debts, obligations,

or liabilities by virtue of his or their being an officer or officers of any of the present constituent synagogues, the Council may direct that any officer or officers for the time being of the United Synagogue shall be entitled to or bound by the same debts, obligations, or liabilities, and such officer or officers shall, when he or they shall be appointed, be entitled to or bound by such debts, obligations, or liabilities, in lieu of the person or persons theretofore entitled thereto or bound thereby. And the accounts which at the date of the establishment of this Scheme are due or accruing due from any person to any of the present constituent synagogues, shall, in determining the question whether or how long such person shall have been in arrear in payment of his accounts to the United Synagogue, and for all other purposes, be considered as forming part of such last-mentioned accounts.

Any bequest contained in the will of a person living at the date of the establishment of the Scheme, in favour of or directed to be administered by or in connexion with any of the present constituent synagogues, or a subsidiary charity or charities of any of the same synagogues, shall take effect in favour of or be administered by or in connexion with the United Synagogue or (as the case may be) the corresponding subsidiary charity or charities of the United Synagogue, and shall be held by the trustee or trustees for the time being thereof upon, with, and subject to such trusts, powers, and provisions as are by such will expressed concerning the same, save and except, and it is hereby declared, that in any case in which a power or discretion shall be by such will reposed in any officer or officers, body or bodies of or connected with any of the present constituent synagogues, such power and discretion shall be, and be considered as having been, conferred upon and reposed in, and shall be exerciseable by the Council, or any committee of the Council, or any officer or officers of the United Synagogue to whom the Council shall delegate the same; and save and except, and it is hereby declared, that in any case in which a person or persons, or a class or classes of persons, or an institution or institutions, standing in any relation to any of the present constituent synagogues, shall be an object or objects named or designated in the said bequest, the object or objects of the same bequest shall be a person or persons, or a class or classes of persons, or an institution or institutions, standing in a similar relation to the United Synagogue generally; and save and except, and it is hereby declared, that the trusts, powers, and provisions by such will declared concerning the said bequest may, in other respects, be from time to time varied and modified by the Council, so far as shall be deemed necessary for the due administration of the same, in connexion with the United Synagogue.

39. The Council may appoint trustees of any such gift, endowment or bequest as is mentioned in either of the last two clauses, and of any property which may hereafter be purchased or acquired by or for the purposes of the United Synagogue or any of its subsidiary charities.

Appointment of new trustees.

40. If any present or future trustee or trustees of any part or parts of the property specified in the schedules, or of any other property now or at any future time belonging to or held in trust for the United Synagogue or any of its subsidiary charities, shall die, or permanently reside abroad, or shall desire to be discharged, or refuse, or become bankrupt, or incapable to act, or be removed by the Council, the Council may appoint a new trustee or new trustees, in the place of the trustee or trustees whose office shall be so vacated; and upon every or any such appointment the number of trustees may be augmented or reduced, but not so as to be permanently reduced below three. Provided that the Council may appoint a corporation authorised by law to act as a trust corporation to perform the trusts relating to all or any of the property hereinbefore mentioned in which event such a trust corporation may be and act as a sole trustee.

Each of the constituent synagogues shall, in respect of such matters of a local nature affecting the same synagogue as are specified in the Scheme and as have been or shall be hereafter determined by the Council, be under the immediate management of a body which shall be called "The Board of Management" of the said constituent synagogue, and shall consist of the two wardens and the financial representative for the time being of the constituent synagogue, who shall be called "The Honorary Officers" of that synagogue, and of not less than five other persons, who shall be called members of the board of management. The said wardens, financial representative, and other members of the board shall be male persons who shall at the duly prescribed date of nomination be schedule members of the said constituent synagogue, of the age of twenty-one years and upwards, and not more than a year in arrear in payment of their accounts to the United Synagogue, and who shall during the whole of two consecutive years immediately preceding such date have been schedule members of any of the constituent synagogues (that is to say, either during the whole of such period at one, or during part at one and the remainder at another or others of the constituent synagogues); and they shall be elected in manner following, that is to say:—There shall be held a meeting at such constituent synagogue annually for the election of such wardens and other members of the board, and in the year 1955 and thereafter biennially for the election of such financial representative; the persons entitled to vote at the meeting shall be all members of the constituent synagogue as defined in Clause 6a (A.) (i), (ii) and (iii), of the age of twenty-one years and upwards, who shall during the whole

of the year immediately preceding the date thereof have been members of the same constituent synagogue, and shall not at the date of the meeting be more than a year in arrear in payment of their accounts to the United Synagogue. For the purposes of this clause, membership, previously to admission, of a synagogue which shall be admitted as a constituent synagogue within the prescribed period of two years or one year (as the case may be), shall be equivalent to membership of the same synagogue as a constituent synagogue, and accounts which at the date of the admission of a synagogue shall be due or accruing due to it from any member, shall, in determining whether or how long such member shall have been in arrear of payment of his or her accounts to the United Synagogue, be considered as forming part of such last-mentioned accounts. In the case of a synagogue admitted as a constituent synagogue within the two years immediately preceding the date of the said meeting, the qualifications for voting and election respectively prescribed in the next succeeding clause (41a) shall apply in substitution for the respective qualifications prescribed in this clause. The male persons to be elected under this clause shall hold office and be members of the board of management from such time in the year of their election as the Council shall determine, until in the year of the next like election their successors shall commence to hold office and become members of the board. In case of either of the wardens or the financial representative of a constituent synagogue dying or resigning or becoming incapable to act during his term of office, a successor may thereupon be elected in like manner, and shall hold office during the remainder of the said term.

In the case of a synagogue newly-admitted as a constituent synagogue, the first wardens, financial representative and other members of the board of management shall be male persons who shall at the duly prescribed date of nomination be schedule members of the age of twenty-one years and upwards, of the said synagogue as a constituent synagogue, and not in arrear in payment of their accounts to the United Synagogue, and they shall be elected in manner following, that is to say: -There shall forthwith, after the admission of such synagogue, be held a meeting at the said synagogue, for the election of such wardens, financial representative, and other members of the board, and the persons entitled to vote at the meeting shall be all members as defined in Clause 6a (A.) (i), (ii) and (iii), of the age of twenty-one years and upwards, who, at the date thereof shall be members of the said synagogue as a constituent synagogue, and not in arrear in payment of their accounts to the United Synagogue. The male persons who shall be elected shall hold office and be members of the board of management from such time in the year of their election, as the Council shall determine, until under the last preceding clause hereof their successors shall commence to hold office and to become members of the board.

The board of management of each constituent synagogue shall annually prepare and submit to the Council a budget or scheme, showing the estimated income and expenditure for the ensuing year in respect of the same constituent synagogue subject to the estimates for expenditure not being inconsistent with clause 58 hereof; and such budget or scheme shall, if and so far as the same shall not be varied by the Council at its annual budget meeting and subject to such variations (if any) as shall be made by the Council at that meeting be deemed to be confirmed and adopted by the Council; and the income and expenditure of the ensuing year, in respect of the constituent synagogue shall, as closely as may be, be regulated by and with reference to the same budget.

DEED OF FOUNDATION AND TRUST

DATED 13th JANUARY, 1871.

Altered and Modified on 31st October, 1926, and 28th February, 1954, in the manner provided by Clause 12 thereof.

TO ALL TO WHOM these presents shall come, WE, SIR ANTHONY DE ROTHSCHILD, Baronet, of 2, Grosvenor Place Houses, Hyde Park Corner, in the county of Middlesex, President of the United Synagogue; LIONEL LOUIS COHEN, of 27, Montague Square, in the said County, Esquire, and SAMPSON LUCAS, of 43, Gloucester Square, Hyde Park, in the said County, Esquire, Vice-Presidents of the said United Synagogue; and Solomon Schloss, of 30, Leinster Square, in the said County, Esquire; and Assur Henry Moses, of 38, Cleveland Square, in the said County, Esquire, Treasurers of the said United Synagogue; SEND GREETING. WHEREAS on the tenth day of February, one thousand eight hundred and sixty nine, a petition was presented to the CHARITY COMMISSIONERS of England and Wales by the Trustees and Governing Bodies of the Great Synagogue, St. James's Place, Aldgate, in the City of London; and the Portland Street Branch Synagogue, Great Portland Street, in the County of Middlesex; the HAMBRO' SYNAGOGUE, Church Row, Fenchurch Street, in the City of London; the New Synagogue, Great St. Helen's, Bishopsgate, in the City of London; the BAYSWATER SYNAGOGUE, Chichester Place, Harrow Road, in the County of Middlesex; and of the subsidiary Charities of the said Synagogues; praying that orders might be obtained for the purposes, inter alia, of establishing a Scheme for the consolidation of the said Synagogues and their subsidiary Charities into one Charity by the title of the UNITED SYNAGOGUE; and for the application and management of the Charities so to be formed; and if it should be doubtful that the Scheme could be carried into complete effect otherwise than by the authority of Parliament, provisionally approving and certifying such Scheme: AND WHEREAS a Scheme was annexed to the said Petition, and it was in a note to the said Petition stated that it was the desire that the Scheme should be in general accordance with the said Scheme annexed thereto: And whereas the said Commissioners provisionally approved and certified the said Scheme: AND WHEREAS, by an Act made and passed in the 33rd and 34th years of the Reign of her Majesty, intituled "An Act for confirming a Scheme of the Charity Commissioners for the Jewish United Synagogue", it was enacted that the said Scheme, as the same was set out in the Schedule to the Act now in recital, should be confirmed and take effect: AND WHEREAS certain provisions contained in the said Scheme (as the same was annexed to the said Petition, and provisionally approved and certified by the said Commissioners) were omitted from, or altered by the said Scheme, as the same was set out in the said Schedule: And whereas it was part of the Contract between the said Synagogues. on the faith of which the said Petition was presented, and the Union of the said Synagogues effected, that the said provisions should form part of the constitution of the said United Synagogue: AND WHEREAS by a resolution duly made and passed, the fourteenth day of December, one thousand eight hundred and seventy, by the Vestry of the said United Synagogue, it was declared that it was an essential part of the Contract between the said Synagogues that the said provisions should form part of the constitution of the said UNITED SYNAGOGUE, and resolved that the same provisions should form part of the said Constitution accordingly, and that, for evidencing and effectuating the said declaration and resolution, the PRESIDENT, VICE-PRESIDENTS, and TREASURERS of the UNITED SYNAGOGUE should, on behalf of the United Synagogue, make and execute a Deed or Instrument embodying and adopting the said provisions: AND WHEREAS in pursuance of the said Resolution, these presents have been prepared, and the said provisions are embodied in, and in substance constitute, the clauses hereinafter contained; NOW THESE PRESENTS WITNESS that, in pursuance of the said resolution in that behalf.

IT IS HEREBY DECLARED as follows:—

- 1. In the interpretation of these presents, the words, "The Scheme", shall mean the said Scheme, as the same is set out in the Schedule to the hereinbefore recited Act; and all words which occur also in the Scheme shall in these presents have the same meaning as they have in the Scheme.
- 2. One of the Objects of the Institution called the UNITED SYNAGOGUE shall be the contributing with other bodies to the maintenance of the Chief Rabbi, and of the Ecclesiastical Board; and the Scheme shall be read and construed as if, in the fifth clause thereof, the words, "the maintenance of the Chief Rabbi, and of the Ecclesiastical Board", were substituted for the words "the maintenance of a Chief Rabbi and of other Ecclesiastical persons".
- 3. The form of worship in each of the constituent Synagogues, and all religious observances in the constituent Synagogues, and all matters connected with the religious administration of the United Synagogue, and of its subsidiary charities, shall, subject to the provision in the Scheme requiring such form of worship to be in accordance with the Polish or German ritual, be under the supervision and control of the Chief Rabbi.
- 3a. THE SYNAGOGUES to which the provisions of Clause 5b of the Scheme shall be applicable shall be Synagogues wherein the form of worship and all religious observances and their religious administration shall, subject to the provision in the Scheme requiring such form of worship to be in accordance with the Polish or German ritual, be under the supervision and control of the Chief Rabbi.

Whenever a vacancy shall occur in the office of Chief Rabbi, or in any other office supported partly by the United Synagogue, and partly by other bodies, the Vestry of the United Synagogue shall arrange with the other bodies in the United Kingdom contributing to the maintenance of such respective office, as to the mode of election, and all details connected therewith.
- 9. In all cases in which religious duties are to be performed in connection with any office, the duties of which relate specially to a constituent Synagogue, no person shall be approved of as a candidate by the Board of Management of such Synagogue, unless the Chief Rabbi certify that he is a fit and proper person to perform the same.

11. Any Synagogue to be hereafter founded and erected under the sixty-fourth clause of the Scheme, shall previously to, and as a condition of, its admission as a constituent Synagogue, be consecrated by or with the sanction of the Chief Rabbi.

12. If, in the opinion of the Vestry, any alteration or modification of the provisions hereinbefore contained, shall be required for any purpose, such alteration or modification, and any variation in the said alteration or modification, may be made in the manner by the sixty-seventh clause of the Scheme provided, with respect to alterations or modifications of the Scheme and variations therein respectively.
