Thank you for your request to Aneurin Bevan University Health Board for information under the Freedom of Information Act (2000) received on 7th February 2024.

Your request

You requested the following:

How many GP surgeries in the health board have ceased to provide services in the last 12 months and could you provide the total amount of services cut, please?

Our response

We have conducted a search of our records and have established that we do hold information relating to your request, as set out below.

7 practices have withdrawn from Enhanced Service (6 different services) in the last 12 months.

Please note that services are categorised as Enhanced Services that practices are commissioned to provide in addition to the core requirements of the NHS General Medical Services contract.

There has been no change to core GMS provision in the last 12 months.

Next steps

If you are not satisfied that the information you have requested has been provided, or because of the way your request has been handled, you have the right to request a review. This would be looked into in accordance with the Information Commissioner's Office (ICO) guidelines, which state that a request for review should be received within 40 days of you receiving the Health Board's response to your request for information.
