Annex A - Your right to complain to DfT and the Information Commissioner

You have the right to complain within two calendar months of the date of this letter about the way in which your request for information was handled and/or about the decision not to disclose all or part of the information requested. In addition, a complaint can be made that DfT has not complied with its FOI publication scheme.

Your complaint will be acknowledged and you will be advised of a target date by which to expect a response. Initially your complaint will be re-considered by the official who dealt with your request for information. If, after careful consideration, that official decides that his/her decision was correct, your complaint will automatically be referred to a senior independent official who will conduct a further review. You will be advised of the outcome of your complaint and if a decision is taken to disclose information originally withheld this will be done as soon as possible.

If you are not content with the outcome of the internal review, you have the right to apply directly to the Information Commissioner for a decision. The Information Commissioner can be contacted at:

Cycle Rail Fund

Over the last 5 years, the Cycle Rail Fund was awarded to Train Operating Companies, via our delivery partner, Rail Delivery Group (RDG), for improvements to cycling infrastructure at stations within their regions. Below is a list of funding awarded to Train Operating Companies for improvements to cycling infrastructure in Shropshire, Cheshire, Staffordshire, Greater Manchester, Merseyside and Lancashire.

Other Government funds that have contributed towards improvements to cycling and walking infrastructure, include:

Transforming Cities Fund

In 2018, the Transforming Cities Fund proposals from authorities included elements of cycling and walking infrastructure improvements. Greater Manchester proposed to spend £160m over 4 years on improving cycling infrastructure on the Beeline cycling network.

Beelines is a cycling and walking network and we expect further cycling and walking content to be developed as part of wider Transforming Cities Funds. Local authorities are still developing their proposals and delivery plans so cycling and walking improvements cannot be separately identified at this stage.

Local Growth Deals

In 2014, 2015 and 2017, the Government announced details of Growth Deals with Local Enterprise Partnerships (LEP) across England.
