Thank you again for replying to my letter and providing documentation in answer to my question. I have trawled through the considerable content in an attempt to discover the process employed and the search for a suitable site for the location the FEZ. I have to confess that I found very little to suggest that the respective planning departments did indeed carry out a search. I have included some extracts of varying relevancy. The final paragraph does mention a "consultation" but ends with the words that none were forthcoming **from landowners or developers!** – so hardly constituting a project by the planning departments to determine the best location.

Easton Landowners Consortium who are, presumably, the landowners promoting the Easton site, declare that no reasonable alternatives have been identified. Lanpro, a planning consultancy, opine that other sites have been considered and discounted for various reasons. If their services were commissioned by the Easton Landowners Consortium and not the planning departments of the councils concerned, then we can assume that the owners of the land and the consultancy are speaking as one vested interest.

I readily admit that I may not be the sharpest tool in the shed so perhaps you would be kind enough to lead me through the documentation to illustrate what I have obviously missed by which I mean evidence of a thorough exercise by the respective planning departments to determine the ideal location or locations for an FEZ. After all, the councils have managed to determine that some 900 houses should be built around Easton, a development which received no objection from me except to insist that adequate road, medical and other infrastructure be provided in a timely fashion. I hope this was not a case of a landowner seeking to make money and the councils finding a project!

# **OBJECT** Cllr Margaret Dewsbury

#### **Summary:**

The site to the west of Easton church on the southern side of the A47 would not be a good site for the Food Hub and cattle market. Large lorries could not use the little back roads so will mainly go onto the roundabout, most will turn towards Norwich stopping traffic coming from Norwich. As this is where the A47 changes from dual carriageway to single lane traffic there is often a tailback, towards the Longwater Lane junction, the Food Hub would make this much worse. Also if lorries arrived at the church roundabout in the morning just as all the residents are trying to leave - it would also cause a tailback in the village. I think there is a better employment site opposite Tesco at Harford Bridges. May I suggest that either of these sites be considered for the Food Hub. If the food Hub were removed it would not be far from its present location. If there is a choice, the land opposite Tesco might be better sited so that lorries could enter the food Hub via a slip road and those leaving the site could leave further down the road in the area controlled by the traffic lights which are already in place. This site would also be accessible from the Mulbarton road - so traffic can be dispersed via two entrances.

#### Proposed Food Enterprise Zone (FEZ) west of Easton

I am a resident of Easton and attended the meeting at Marlingford Village Hall on 10 May 2016. The village hall was packed with local residents and we were addressed by two gentlemen, the chief planning officers of South Norfolk Council and Broadlands Council. Unfortunately, I did not catch their names; neither can I find them on the two council websites. I hope they will accept my apologies for the omissions. I am sending this letter in the hope that one or other of them, viz. the planning officers, will oblige me with a reply or will direct my request to the appropriate official.

One of the main issues raised by residents was the reason for choosing the proposed location for this FEZ. Given the presentation made by the two officers present, the audience could not escape the conclusion that the sole

reason for the work in progress in the various planning departments was the fact that a certain landowner had offered the site for development. There could be few, if any, present at the meeting who found this anything but bizarre!


Surely, it is conventional practice for planning departments to establish a need and then to determine the best location for satisfying that need. One gentleman in the audience offered an opinion that a much better location for the FEZ would be in the area of the Thickthorn roundabout on the A47. He made some excellent justifications for his proposal. The planners present undertook to investigate this suggestion.

I have studied the document dated April 2014 and last updated 12 May 2016- APPENDIX A - BROADLAND COUNCIL & SOUTH NORFOLK COUNCIL - Public Participation Statement for the Draft Food and Agriculture Hub. I had hoped that further light would be shed on what led the Council to its current planning exercise. I may have missed it but I found no answer to the question apart from mention that "during 2011/12 proposals for a food hub at Honingham/Easton were put forward" but subsequently, in the same paragraph, "the decision was taken by South Norfolk Council not to support allocation of the site". Later in the same document it says that "the SPD is deliberately not specific about the potential location of a Food Hub, but instead sets out a range of criteria".

I would like to know details, including timings, of the various machinations which led up to the current planning exercise for the location of the FEZ to the west of Easton. Given that all who work for the planning departments and indeed the officials of the whole council, are paid through the taxes levied on us local residents, I think we are entitled to have this un-redacted information under the auspices of the Freedom of Information Act. Council officials are accountable to the electorate and I trust that they would wish to be seen to be not only accountable but also sympathetic to public opinion, especially that voiced by localised groups such as residents who will be severely disadvantaged if this development goes ahead in the current proposed location.

I did not detect any objection voiced by the residents to the principle of the **establishment** of an FEZ but the two planners present at the meeting in the Marlingford Village Hall could only have concluded that there was unequivocal opposition to the **location** of this FEZ by all those present in the audience. In view of the national government's stated intention to localise democracy, including planning decisions, I look forward to receiving the information requested in the previous paragraph and to witness a very clear move by the planners to abandon the west of Easton site in favour of a more suitable location.

I am sending a copy of this letter to the three email addresses which appeared on the flyer produced by Resident Against Industrial Development (RAID) which was posted through my door. In addition, I am adding other addressees who might have an interest including the two chief executives of the councils concerned as I feel sure that they would wish to evaluate their mission statements regarding public support for planning policies against the anger and frustration expressed by local residents at the meeting.

Thank you for your email below which Phil Courtier forwarded to me for a response on the basis that it is me who has been tasked with considering a Local Development Order (LDO) on a 20ha site which falls within Broadland administrative area. The concerns that you raise are noted and I agree that such matters will need to be taken into account.

The 'Food Hub' concept is established in principle by virtue of the adopted Joint Core Strategy Policy 5. The adopted Food Hub Supplementary Planning Document, which can be found here. http://www.broadland.gov.uk/housing and planning/5737.asp expands upon this. The Greater Norwich Food Enterprise Zone (FEZ) encompasses a large swathe of land extending from Honingham in the west to the Norfolk Showground in the east and includes Easton College. The LDO is being considered on land within this area that is being promoted as a food and agriculture hub by the land owner.

The precise detail of exactly who will be operating on the site and what will be produced is not vet certain but the Food Hub Supplementary Planning Document identifies a broad range of uses. The purpose of an LDO is to simplify the planning process by setting out a set of parameters that will need to be accorded with in order for development to be considered acceptable. This allows businesses to locate on the site quickly and easily, provided that they accord with the terms of the LDO.

A view is currently being sought from the relevant statutory consultees as to whether the proposed LDO is likely to give rise to any significant adverse impact e.g. in respect of the highway network, noise, dust, odour etc. If it is decided to pursue an LDO, the draft Order is required to be the subject of a consultation exercise. I would strongly encourage you to ensure you raise any concerns you have at this time.

#### Dear Mr Courtier,

Thank you for your presentation at the Easton Parish Council Meeting on Monday 13<sup>th</sup> March 2016 regarding the proposed Food Hub. While I appreciate these are early stages I feel it is important to convey my concerns at the earliest possible moment and will continue in doing so.

While the premise of the Food Hub is a good one by promoting, processing and distributing locally grown produce the location clearly is not. And disturbingly by planning a Local Development Order it outwardly appears the proposal could also ride rough shoot over planning regulations and the local community as a whole.

Areas of great concern are:

➤ Transportation. An increase in all types of traffic movement would be difficult to manage and with Highways England already classifying our network as "clunky at best" it is difficult to understand how this can be accomplished given the proposal may be in place before the duelling of the A47 between Easton and North Tuddenham.


Being unable to confirm the type of vehicles using the food hub also underpins my concerns with regards operating restrictions and most importantly the devastating affect it may have on our Church, St Peters.

- ➤ Operating Times. Being situated west of the village of Easton the prevailing wind will carry, smell noise and dust over and into our village. Initial planning restrictions over times of operations will very quickly be amended once the plant is in place allowing for potentially 24 hour operations. Growth of any business is key to sustain business and this will be no different. A company entering the food hub for trade will soon apply for extensions to trade and no District Council will refuse it for the fear of loss of revenue and loss of employment. 24Hour operations and vehicle movement is not what anyone living in the local vicinity has signed up for and I am positive it will have a devastating effect on many lives of those who live here.
- ➤ Classification of business. The term Food Hub is very ambiguous and clearly does not define potential business activity. I am assuming agricultural and factory style units located around the site with processing plants, washing, chopping and packing vegetables and meats. Taking produce through to a consumer point of sale product. Where meat products are involved an abattoir will not be far away. Clearly it would not make sense to house the Cattle Market on site to transport livestock to an offsite abattoir to then only return the carcase back to the food hub. These activities are energy hungry, water hungry, produce large volumes of waste and noise. At what point within the coming 12 to 18 months will we be in a position to actively know the activities being planned for on the site. These will need to be known before acceptance of a LDO in my opinion.

It is very hard to understand, other than for a council's revenue stream, as to why this locations is being pushed for when it is clearly not fit for purpose. At the meeting on Monday the representative from South Norfolk stated no other land owners came forward. How are we to confirm this? Is it to be believed that in the rest of Norfolk no one

else voiced an interested in housing this plant? There are numbers of locations, and these being brown field sites not green field, around the Norwich area and further afield that can take, manage and offer greater resources in terms of transport than our village. What guaranteed assurances will we as residents of Easton have this production plant will not affect us in any manner?

With the great support from outlining Parish Councils attending Mondays meeting it also appears I am not alone with my fears. It was also very prudent of the vice chair of Easton Parish Council to relay the Prime Minister's comments about listening to local Parish Councils. I do so hope this is taken on board as it appears outlying parish councils also have the same fears. In many ways I sincerely hope this plant will never grace our landscape. Yours Sincerely

The proposed site of the Food Enterprise Zone in Easton seems completely inappropriate.

With planning permission recently granted for an additional 900 homes, increasing the exiting 600 homes buy about 150%, I think Easton has had more than its fair share of development and there are plenty of other more appropriate sites for an industrial development alone the A47 corridor.


Indeed with the additional 900 houses, some extending in the direction of the proposed the proposed industrial development this will have even more of an impact on these.

Also the current access to the A47 at the western end of Easton is already a bottle neck in the rush hours and also potentially dangerous in lighter traffic.

Due to the limited line of site of traffic approaching from east to west on the A47 pulling onto the roundabout from Easton can be precarious with some cars approaching on the A47 at excessive speed and the limited view necessitating sharp braking when all seemed clear, with increased traffic and especially lorries this is only going to increase this risk. There has been no provision made for the extra traffic from the additional 900 homes let alone that generated by this proposed development.

Lastly I am concerned that planning decisions are being made in isolation as I can't understand how another major development can be considered in Easton after one has already been approved and the cumulative impacts are not being measured only individually.



Thank you for your comments on the potential food hub. At present there is no planning application or other specific proposal to object to, therefore I have registered your comments under a general enquiry on the Council's Planning system (Ref: ENQ/2016/0585).

As you may already be aware, the concept of a food hub for the Greater Norwich area was established in Policy 5 of the Joint Core Strategy (JCS) for Broadland, Norwich and South Norfolk (http://www.south-norfolk.gov.uk/planning/6501.asp). Following the adoption of the JCS. South Norfolk and Broadland Councils have produced and adopted a Supplementary Planning Document (SPD) which elaborates on this aspect of JCS Policy 5, setting out the main criteria for assessing proposals for a food and agriculture hub. The SPD can be downloaded from the Council's website at: http://www.south-norfolk.gov.uk/foodhub. Neither the JCS nor the SPD are site specific.

More recently a Food Enterprise Zone (FEZ) has been designated for an area which stretches from Honingham Thorpe Farms in the west to the Royal Norfolk Showground in the east and

includes Easton and Otley College and Pasta Foods. Within the FEZ Broadland Council is currently in the process of considering the potential for a Local Development Order (LDO) on an area which is being promoted by a land owner for a food hub between Easton and Honingham. The precise details of what will occur within the LDO area are not yet established; however, the SPD gives a useful indication. An LDO is designed to simplify and speed up the planning process by setting out a set of parameters/conditions for potential development and any development that then complies with those conditions does not require a separate planning permission.

Broadland Council is currently seeking views from various technical consultees on whether the LDO is likely to give rise to significant adverse impacts on aspects such as highways network, pollution and landscape/heritage. If Broadland Council decides to pursue an LDO, a draft Order would need to be consulted on. Consequently I would encourage you to raise any concerns at this time, as these could help shape the conditions that would apply to any businesses seeking to locate at the Food Hub. In the meantime I will forward your e-mail to Broadland Council so that they are aware of your concerns.



The village hall was packed with local residents and we were addressed by two gentlemen, the chief planning officers of South Norfolk Council and Broadlands Council. Unfortunately, I did not catch their names; neither can I find them on the two council websites. I hope they will accept my apologies for the omissions. I am sending this letter in the hope that one or other of them, viz. the planning officers, will oblige me with a reply or will direct my request to the appropriate official.

One of the main issues raised by residents was the reason for choosing the proposed location for this FEZ. Given the presentation made by the two officers present, the audience could not escape the conclusion that the sole reason for the work in progress in the various planning departments was the fact that a certain landowner had offered the site for development. There could be few, if any, present at the meeting who found this anything but bizarre!

Surely, it is conventional practice for planning departments to establish a need and then to determine the best location for satisfying that need. One gentleman in the audience offered an opinion that a much better location for the FEZ would be in the area of the Thickthorn roundabout on the A47. He made some excellent justifications for his proposal. The planners present undertook to investigate this suggestion.

I have studied the document dated April 2014 and last updated 12 May 2016- APPENDIX A -BROADLAND COUNCIL & SOUTH NORFOLK COUNCIL - Public Participation Statement for the Draft Food and Agriculture Hub. I had hoped that further light would be shed on what led the Council to its current planning exercise. I may have missed it but I found no answer to the question apart from mention that "during 2011/12 proposals for a food hub at Honingham/Easton were put forward" but subsequently, in the same paragraph, "the decision was taken by South Norfolk Council not to support allocation of the site". Later in the same document it says that "the SPD is deliberately not specific about the potential location of a Food Hub, but instead sets out a range of criteria".

I would like to know details, including timings, of the various machinations which led up to the current planning exercise for the location of the FEZ to the west of Easton. Given that all who work for the planning departments and indeed the officials of the whole council, are paid through the taxes levied on us local residents, I think we are entitled to have this un-redacted information under the auspices of the Freedom of Information Act. Council officials are accountable to the electorate and I trust that they would wish to be seen to be not only accountable but also sympathetic to public opinion, especially that voiced by localised groups such as residents who will be severely disadvantaged if this development goes ahead in the current proposed location.

I did not detect any objection voiced by the residents to the principle of the **establishment** of an FEZ but the two planners present at the meeting in the Marlingford Village Hall could only have concluded that there was unequivocal opposition to the **location** of this FEZ by all those present in the audience. In view of the national government's stated intention to localise democracy, including planning decisions, I look forward to receiving the information requested in the previous paragraph and to witness a very clear move by the planners to abandon the west of Easton site in favour of a more suitable location.

I am sending a copy of this letter to the three email addresses which appeared on the flyer produced by Resident Against Industrial Development (RAID) which was posted through my door. In addition, I am adding other addressees who might have an interest including the two chief executives of the councils concerned as I feel sure that they would wish to evaluate their mission statements regarding public support for planning policies against the anger and frustration expressed by local residents at the meeting.



#### **LDO / Food Enterprise Zone at Easton**

We strongly object to this proposed development for the following reasons:-

#### **Environment**

- Our unique, quiet, rural, village environment will be irrevocably and detrimentally changed as a result of this proposed development.
- The Yare valley flood plain, as designated by the Environment Agency, is just a mile or so from this proposed development; it is inevitable therefore that the huge carbon footprint of such a development will have an adverse detrimental impact on this unique environment. We are also very concerned about the impact that the development will have on the Yare valley flood plain. Our garden backs onto the river Yare and regularly floods in the winter months, in fact it has done so on occasions during the summer in recent years; We suspect due to the influence of global warming. We believe that the proposed development will increase the frequency and severity of flooding in this area.

#### **Pollution**

- Traffic Heavy Lorries, service vehicles and site worker's cars travelling to and from the Food Enterprise Zone will constitute a major increase in traffic using local roads. This will result in large volumes of CO2 emissions into the atmosphere. There will also be pollution from dust, noise and diesel spillage. Our country lanes and roads will become more dangerous and there will inevitably be an increase in accidents.
- Water It is inevitable that pollutants resulting from the construction and use of the Food Enterprise Zone will find their way via underground water courses into the river Yare.
- Noise There will be noise pollution from construction plant, machinery and heavy Lorries during the creation of the Food Enterprise Zone and ongoing noise pollution from vehicles using and servicing the Food Enterprise Zone when operational.
- **Dust & Dirt** Airborne dust and pollution from the construction and use of the Food Enterprise Zone will hang over the river valley and lorries and service vehicles will spread dirt and mud on our local roads, making them less safe to drive on.

 Light – There will be light pollution to the night sky from flood lighting, security lighting and vehicles.

# **Quality of Life**

Our environment will be degraded and changed forever. Our right to enjoy the amenities of our home and garden will be spoiled by the noise, dust and air pollution created by the construction process and high volumes of traffic servicing and using the Food Enterprise Zone; as a direct result our health and safety will be put at risk.

# **Highways**

- It is inevitable that the traffic using our local roads and country lanes will dramatically increase if the proposed Food Enterprise Zone goes ahead, with consequential damage and degradation to the infrastructure of our community. It is also inevitable that Food Enterprise Zone traffic will use local roads and lanes as short-cuts to the A11.
- The A47 is probably the most congested road servicing Norwich, what person in their right mind would even consider such a development?
- What assessments have been conducted in relation to the inevitable road accidents and fatalities resulting from the construction of the Food Enterprise Zone?
- Easton and Otly College is within walking distance of the proposed Food Enterprise Zone, how
  will this development impact on the student's safety as they travel to and from the College?

#### Conservation

- Has an Environmental Impact Assessment been conducted?
- During recent years work has been undertaken on the flood meadows opposite to our home to improve the habitat for wildlife and to attract additional bird species to the area, an initiative that we support and applaud. It is rather ironic however that land just a mile or so away is being considered for such an unnecessary, inappropriate and large development.
- We understand that the area where the habitat improvements have been made is designated as a Higher Level Stewardship scheme by Natural England. A considerable range of wildlife live in this area, we have personally seen (and filmed) a family of otters in the river at the bottom of our garden. What impact will the proposed Food Enterprise Zone have on the rich diversity of wildlife that currently live in and benefit from this unique habitat?

It would be appreciated if you would send us an acknowledgement of receipt of this email and a personal response to the issues that we have raised.
