I refer to your request for information dated 17 November 2012, which was received by Strathclyde Police on same date.

I am writing to request information from the Chief Constable of Strathclyde Police pursuant to the provisions of the Freedom of Information (Scotland) Act 2002. The information I request relates to guidance issued to police officers.

I seek from Strathclyde Police the content of any documents issued to Police Officers which are designed to provide guidance on or instruction as to the investigation or management of the following:

- (a) Sexual Offences
- (b) Missing persons
- (c) public order offences

All Strathclyde Police Policies are available on the Force Intranet Website for the information of Police Officers and Police Staff.

While there is an expectation that staff will follow the prescribed procedures, it is recognised that every eventuality cannot be covered and accordingly, officers will require to exercise their professional judgement and common sense. Any subsequent analysis of actions will be judged on the grounds of reasonableness in the light of all the facts and circumstances rather than solely on non-compliance with the relevant S.O.P. Where such discretion does not exist this will be clearly indicated.

Whilst memos are issued regularly with updates and departments may issue in-house guidance, this is all based around the Standard Operating Procedures for the Force, therefore, with regards to your request I have identified 6 documents which are relevant to your request, namely:

Once informed of the Review Panel's decision, if you are still not satisfied, then you are entitled to apply to the Scottish Information Commissioner within six months for a decision.
