I can confirm that Southern Health NHS Foundation Trust holds the information you requested:

I am interested in the relationship (if any) between your organisation and the Hampshire Health Record (clinical data repository).

- Please could you tell me whether your organisation has commenced extracting and uploading personal confidential hospital data about patients to the HHR?
 Southern Health NHS Foundation Trust has commenced extracting and uploading information about patients to the HHR.
- If not commenced already, do you have plans to commence feeds into the HHR at any time between now and 31st March 2017?

• Any and all policies on the implementation of HHR feeds by your organisation. The implementation of HHR feeds by our organisation began prior to the establishment of Southern Health NHS Foundation Trust. The Trust was established in April 2011 through the merger of two predecessor NHS bodies, Hampshire Partnership NHS Trust and Hampshire Community Health Care, and therefore any policies regarding the implementation of HHR feeds would have been created by each of these predecessor NHS bodies.

We therefore believe that any policies on the implementation of HHR feeds by these bodies would be held by NHS South, Central and West Commissioning Support Unit. They are hosted by NHS England, and therefore under our section 16 duty to provide


