	The following module summary is based on the requirements set out in: Part 2: Standards for student supervision and assessment (2018). The Standards set out the expectations for the learning, support, supervision and assessment of students in the practice environment and are reflected in all CP modules. Nursing students will learn and be assessed in theory, simulation and practice environments. During this module, students will undertake seven weeks (37.5 hours/week: 337.5 hours) of learning within a Practice Learning Environment (PLE) and will be supernumerary to the normal staffing complement. Each student be allocated a practice supervisor who may be a registered health or social care professional and will support and provide oversight of practice supervision to ensure safe and effective learning. The practice supervisor will support learning in line with the students' scope of practice to enable the student to meet their proficiencies and programme outcomes, providing feedback on both their progress and achievemen proficiencies and nursing procedures.	
	Students will be assigned a nominated practice assessor who are registered nurses with appropriate equivalent experience for student's field of practice. Assessment decisions by practice assessors and confirmation that the student has achieved proficiencies and programme outcomes for practice learning are informed by a range of sources including feedback from practice supervisors, the students' conduct, proficiency and achievement, student records, direct observations and student self-reflection.	
	Nursing students will be empowered to be proactive and to take responsibility for their practice learning. Timely access to placement information will help to ensure students can prepare for placement and can plan to access the learning opportunities that are identified as part of routine placement audit. At the beginning of each placement the learning opportunities that are relevant for students at different stages in the programme will be negotiated between the supervisor and the student and will help to support students'	

	achievement of proficiencies and programme outcomes for practice learning.
	The Practice Assessment Document (PAD) is used to facilitate and guide student's practice learning to achieve the criteria set out in the NMC standards (2018) and contributes to a significant part of the students overall assessment. The PAD summaries achievement in each placement and provides a comprehensive record of professional development, practice performance and achievement of nursing procedures and proficiencies.
	Each student will have an identified academic assessor (Personal Academic Tutor) who will collate and confirm student achievement of proficiencies and programme outcomes in the academic environment for each part of the programme.
