Request under the Freedom of Information Act 2000 (the Act)

Thank you for providing your name in accordance with section 8(1)(b) your request is now a valid request. The council has considered your request, which included your name, which was received on 11 April 2019, and our response to your questions is shown below.

Complaints to Magistrates for Council Tax (CT) Liability Orders.

Going as far back as is reasonable (eg 5 years), up to the most recent data available, Please could you provide me with a table of information under the following headings:-

- 1. Date Of hearing
- 2. Number of CT Accounts Listed on a Complaint
- 3. Total Court fee paid
- 4. length of hearing defended/undefended
- 5. Number of CT accounts Liability Order made against
- 6. Total costs awarded to Billing authority
- 7. Actual cost of preparing for and attending the hearing.
- 8. Number of Accounts in name of a Limited Company?

In accordance with section 1 (1) of the Act the council has a duty to confirm whether it holds the information of the description specified in the request, and if that is the case, to have the information communicated to the requester.

Regard parts 4 and 7 this is not recorded and cannot be supplied therefore, under section 1 of the Act some of the requested information cannot be provided, as it is not held by the council.

Regarding part 8 of your request, whilst the council will have a record of accounts in name of a Limited Company, we do not hold a record the number of orders issued against limited companies for each court. It has been estimated that to manually,



identify, interrogate, extract and then compile this information would exceed the appropriate limit. As per guidance from the Information Commissioner's Office (ICO), when estimating the cost of compliance, we can take into account the cost of the following activities:

- · determining whether you hold the information;
- finding the requested information, or records containing the information;
- retrieving the information or records; and
- extracting the requested information from records

In order to answer this part of your request an officer would be required to manually go through every cost list, check the council tax records for each of the accounts listed on the complaint top identify if there were a limited company, and then count each account in the name of a limited company. As per the data provided below this would require looking through thousands of records, which the council estimates would significantly exceed the appropriate limit. Therefore, on this occasion, the council has decided to exempt itself, from complying with this part of your request as the cost incurred in providing a response would exceed the appropriate limit of £450, which is equivalent to requests that would require more than 18 hours continuous work.

The council is withholding some of the information you have requested as detailed above under section 12, please accept this letter as a partial refusal notice issued in accordance with section 17 of the Act.

Paragraph 14 of the section 45 Code of Practice states that when the council is not obliged to comply with a request because it would exceed the appropriate limit to do so, then it: "...should consider providing an indication of what, if any, information could be provided within the cost ceiling." See below for information in response to parts 1, 2, 3, 5 and 6 of your request. The council have also attached a letter along with a cost breakdown issued to the Magistrates Court justifying the costs of £70 levied for each order obtained.
