

Would you please confirm that Bamford Clough is a Byway Open to All Traffic (BOAT) and that its condition is maintained at Public Expense?



Bamford Clough – Bamford BOAT 17

I refer to your letter of 7 February 2017 and your Notice pursuant to S56 Highways Act 1980 dated 21st February 2017.

I can confirm that:

- a) The route is maintainable at public expense.
- b) The County Council maintains this highway

I can further advise that the route is temporarily closed on the grounds of public safety owing to an exposed electricity cable. I am sure you are anxious to know what progress is being made towards the repair of the route. I am due to attend a meeting in early March to discuss the complications of the scheme with our engineering and legal advisors. The aim of this meeting is to work out how to manage the cable and of course, repair the route. We have been advised not to touch the cable and therefore we shall be liaising with the owner as soon as possible after the meeting. To complicate matters the cable has been covered in concrete along parts of the route (not by the owner or the County Council) and this will prevent the cable from being moved so whatever the solution it is going to be very, very expensive.

Surfacing of the route is proving a challenge. We have determined that sections of it cannot be repaired safely and therefore we may have to resort to specialist support to repair and provide a sustainable surface.

Whilst I share your frustration over the closure of the route, we are now in a position to work forward towards opening the route in 2018.
