Dear Mr Short

I refer to your request dated 3rd March 2017 made under the Freedom of Information Act 2000 for information about the breakdown of income tax spent on transport. Specifically you asked:

"a percentage of Income Tax is described as being spent on Transport. Can you provide any further breakdown of what elements of Transport e.g. road construction / repairs this money is spent on."

I have interpreted your request to refer to the annual summary of income tax that is sent to taxpayers by HMRC. I am writing to advise you that this Department does not hold any recorded information that would show the breakdown of income tax spent on transport. Transport is funded from general taxation, of which income tax is only one part; and the Department only holds records on transport expenditure incurred by central government, not local government.

Although we cannot, therefore, directly answer your question, you may find the following documents are of interest.
