### **FREEDOM OF INFORMATION ACT 2000 - REQUEST REF: FOI2021/23730**

Thank you for your email of *date of request* asking for information under the Freedom of Information Act (FOIA) 2000. You asked:

*Under the provisions of the Freedom of Information Act 2000, I am writing to request the latest versions of any Pan American Health Organization / World Health Organization Hospital Safety Index evaluation reports held by FCDO for the following health care facilities:*

- 1. Heath care facilities that are part of the Smart Health Care Facilities in the Caribbean project funded by FCDO.*
- 2. Health care facilities in Bermuda and British Overseas Territories in the Caribbean.*
- 3. Health care facilities in Commonwealth countries in the Caribbean, Central America and South America.*

*Given the potentially sensitive nature of some of this information, I ask you to redact any exempt information instead of refusing disclosure. This would be in accordance with guidance on best practice from the Information Commissioner's Office.*

I am writing to advise you that following a search of our paper and electronic records, I have established that the information you requested is not held by this Department.
