I understand that you are seeking the following information:

- 1) A complete list of all land that the college owns, including its approximate value.

I confirm that the College holds some of the information that you have requested, and respond to your request as follows:

- 1) Information relating to our individual properties and land values are withheld in accordance with the exemption under Section 43(2), as this would prejudice the commercial interests of the College. We do not consider that there is a material adverse effect on the public interest.
- 2) The information provided in Appendix A is based on an independent valuation of the College's assets in 2014. Further information and up-to-date figures regarding our fixed assets can be found the College accounts at the following URL:
