Dear Trudy Baddams,

Thank you for your Freedom of Information request received on 20 January 2015. You asked:

"How many disabled have moved into full time work in 2013 /2014 (not including part time or zero hour contracts, nor workfare / work programmes, nor training.

How many disabled on sick note were moved into work fare / work programmes in 2013 / 2014."

In response to the first part of your query, we can confirm that DWP does not hold this information.

Regarding the second part of your query, we can confirm that the Department may hold some information falling within the description specified in your request. However, we estimate that the cost of complying with your request would exceed the appropriate limit of £600.

The appropriate limit has been specified in regulations and for central Government it is set at £600. This represents the estimated cost of one person spending 3½ working days in determining whether the Department holds the information, and locating, retrieving and extracting the information. Under section 12 of the Freedom of Information Act (FOIA) the Department is not obliged to comply with your request and we will not be processing your request further.

Under section 16 of the FOIA we are obliged to assist you in providing options to narrow your request, by reforming or refocusing it, so that it will fall beneath the cost limit. Unfortunately in this case we are unable to provide any information on sick notes within cost, however other relevant information is provided below.

- 2. Under Analysis, select Job Outcomes (Thousands)

- 5. Under Subset, select NONE
- 6. Under Date, select the latest date available, which at the time of request was September 2014

Please note that Disability Indicator shows those **self-assessed** as having a physical or mental impairment which has a substantial and long-term effect on their ability to carry out normal day to day activities.
