Dear Trudy Baddams,

Thank you for your Freedom of Information request of 29 September 2016. You asked:

How many people die before reaching retirement age? How many people die before claiming their stateam pension? How many of these are men and how many are women? What percentage of people died before claiming the state pension in 2015?

I can confirm that we hold information falling within the description specified in your request. However, we estimate that the cost of complying with your request would **exceed the appropriate limit for central Government, set by regulations at £600.** This represents the estimated cost of one person spending 3½ working days in determining whether the Department holds the information, and locating, retrieving and extracting it.

Under section 12 of the Freedom of Information Act the Department is not therefore obliged to comply with your request and we will not be processing it further.

Under section 16 of the Act we should assist the requester in helping narrow their request so that it may fall beneath the cost limit. You might like to narrow your request by specifying a time period.

We will consider afresh any revised request however we cannot guarantee that any revised request will fall within the cost limit.

You may be interested to know that the Office for National Statistics (ONS) publishes mortality statistics which can be found here:

https://www.ons.gov.uk/peoplepopulationandcommunity/birthsdeathsandmarriages/deaths

In particular, the publication 'Death registrations summary tables - England and Wales', within the 2015 supporting table provides registered deaths by individual year of age and gender which may be of most interest.
