<u>Comments on the Hungerford Town Action Plan – Returned 26th February 2013</u>

Highways & Transport Service

Are Tr5 - Tr5c new actions? My comments are:

Tr5 - This implies that there is a road safety issue on the approaches to Hungerford, which there is not. I would suggest the wording 'Continue to monitor road safety on the A4'

Tr5a - There are already Gateway features on the A4 and a VAS is not considered appropriate.

Tr6b – Improved Gateways can be considered and a 30mph VAS is not appropriate for this approach.

Tr5c – Improved Gateways can be considered and a VAS is not appropriate as there is not a speeding issue at this location.

Recent surveys show that for northbound traffic approaching eth roundabout the average speeds was 24.8mph with 85th percentile speed of 30mph.

Line 139 As 99 above. To promote information effectively about what's going on, the local Library and the WBC website are crucial.

Line 147 N.B. Police are welcome to use libraries to meet the public, e.g. for regular or occasional surgeries. The Fire Brigade have also run occasional surgeries in libraries (recently at Lambourn) to give advice on fire prevention, etc.
