The Trust uses the following hysteroscopy equipment:

- LiteOptics – Outer sheath diameter of 4.3mm
- Karl Storz – Outer sheath diameter of 4.2mm
- Karl Storz- Alpha Scope – Model Gynecare GMS40A 1.8mm.
- Johnson & Johnson - Ethicon hysteroscopes
- Schultz Medical - Gynix Hysteroscopic Sheath 18cm outer diameter, 3.5mm inner diameter.
