TH - 10 pump fire

Caller is reporting that there is a large 10 pump fire, 2 water carriers and a ariel ladder platform. There is a range of buildings, acetylene cyclinders. This is on Littleton Lane, Shepperton. The building is Bretts Aggregates. Log 9570 NIRS 679565.

The Fire Service have called us up with an update, There is a large amount of Tar & Oil Residue, heading towards 800 square metres of water, could someone please call them as soon as possible.

For our information only.

Mohammed Jama called out whilst on standby on the 18/05/09 @ 18:30. Met with FBrigade on scene. Most of the fire water used on site has infiltrated through the ground. Was unable to ascertain drainage on site. JArikans was not able to obtain drainage info via Thames Water. Contaminated debris/tar/oil residue was being held back by use of hoses. Advised FBrigade to put booms out to prevent debris mixing further with water on site and from entering lakes until EA attendance the following morning. Advised FBrigade to make use of grab packs on drains. FBridgade advised me that less water was being used as fire had been put out. Runoff into lakes was examined and showed some evidence of fire-water entering lake, otherwise majority of fire-water had infiltrated ground. Fire investigation officer Mr Bryn Strudwick informed me that the burning of tyres on this site has happened 3 times before and this area is a haven for illegal waste activities. Mr Strudwick would like the responsible team to contact him.
