Freedom of Information Act 2000 (FoIA)

This request has been handled under the above legislation. You asked:

- 1. How many UK born individuals are currently living in social housing in Solihull Borough?*
 - 2. How many foreign born individuals are currently living in social housing in Solihull Borough?*
 - 3. How many UK born families are currently living in social housing in Solihull Borough?*
 - 4. How many foreign born families are currently living in social housing in Solihull Borough?*
 - 5. How many UK born individuals are currently on the waiting list for social housing in Solihull Borough?*
 - 6. How many foreign born individuals are currently on the waiting list for social housing in Solihull Borough?*
 - 7. How many UK born families are currently on the waiting list for social housing in Solihull Borough?*
 - 8. How many foreign born families are currently on the waiting list for social housing in Solihull Borough?*
- I would also like to know the previous years' figures for UK born individuals/families and foreign born individuals/families who are currently living in social housing or on the waiting list.*

It has been established that the information you requested is not held and are advising you of this, as required by Section 1(1)(a) FoIA. We are only required to confirm a right of residency for housing applications, not the country of birth.

I trust this information is of assistance. However, if you are dissatisfied with the response and wish to request a review of our decision or make a complaint about how your request has been handled, you should write to the following address or reply to the email to which this letter is attached:

If having exhausted the review process you are not content that your request or review has been dealt with correctly, you have a further right of appeal to the Information Commissioner's Office (ICO) for a decision. Generally, the ICO will not make a decision until you have exhausted the complaints procedure provided by the council.
