Dear Pauline Budd,

Thank you for your Freedom of Information (FoI) request received on 30 April. You wrote:

"I have again read that many impact assessments were made in relation to the impact on women prior to increasing state pension age (twice). I would like to read these assessments, where can I find them? Can you provide me with copies? You cannot keep saying that impact assessments were made without providing the evidence and allowing us to read them."

DWP Response

We confirm that we hold the recorded information to answer your request.

In answer to your main question, multiple assessments were undertaken on the impact on both men and women.

The 2006 impact assessment 'The Gender Impact of Pension Reform' considered a wide range of reforms to both state and private pension systems, including proposed State Pension age changes, and can be found here:
