REQUEST UNDER THE FREEDOM OF INFORMATION ACT 2000

Further to your enquiry, which we received in full on 08 February 2017, you requested the following information:

- The number of incidents attended at prisons and youth detention centres in each year from 2011 to 2016?
- The number of these incidents which were linked to 'legal highs' or 'NPS' such as 'Spice' or 'Black Mamba'? Please provide figures broken down by year.

On 08 February 2017, we advised

I can confirm that unfortunately, we do not record drugs as a chief complaint. We could categorise such incidents as an "overdose", but this is based on the information provided by the caller at the time and therefore may include both legal and illegal drugs, prescription medicines and alcohol related incident. This does not also encompass any other incidents which may have drugs related to it and are not be logged as the primary cause of the complaint such as "fall", "convulsion" etc.

Do you still wish to proceed with the first question of your request - the number of incidents attended to prisons and youth offender centres? If so, would you like this information by calendar year or the appropriate financial year?

On 09 February 2017, you confirmed you would like to proceed with the first part of your request with figures provided for each calendar year.
