Hi David / Gary

Noting today's announcement of the extension of Delay Repay to 15 minutes, I would request that the implementation of this provision incorporates clarity on the status of multi modal zonal tickets such as MCard in this regard.

Northern and TPE have both firmly held the position that Delay Repay does not apply to MCard customers. This has resulted in customer disputes for which neither the CA nor the West Yorkshire Ticketing Company (WYTCL) can offer a satisfactory resolution. One such complaint to a local MP resulted in the attached response from a DfT official which clearly states that it does apply.

We have made the TOCs aware of this correspondence however it would be useful to obtain full clarity on the matter through the franchise process.
